#### THE CROYDON (FREE PARKING PLACES) (DISABLED PERSONS) (NO. 5) TRAFFIC ORDER 2000

Notice is hereby given that the Council of the London Borough of Croydon on 15th May 2000, made the above-mentioned Traffic Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985. The general effect of the Order would be to:

- (a) revoke the disabled parking places located outside No. 73 Alexandra Road, East Croydon, outside No. 91 Broughton Road, Thornton Heath, outside No. 34 Dennett Road, West Croydon, outside No. 22 Ederline Avenue, Norbury, outside No. 11 Grove Road, Thornton Heath, outside No. 92 Harcourt Road, Thornton Heath, outside No. 10 Jarvis Road, South Croydon, outside Nos. 66, 70 and 83 Leander Road, Thornton Heath, outside No. 9 Marlborough Road, South Croydon, outside No. 17 Raymead Avenue, Thornton Heath, outside No. 80 Ross Road, South Norwood, outside No. 65 St. Saviours Road, West Croydon and No. 5 Stokes Road, Shirley adjacent to No. 129 The Glade;
- (b) designate new parking places in Davidson Road, Croydon (outside No. 35), Denning Avenue, Waddon (outside No. 55), Dovercourt Avenue, Thornton Heath (outside No. 9), Lodge Lane, New Addington (outside Nos. 551 to 637), Montpelier Road, Purley (alongside No. 65), Nursery Road, Thornton Heath (adjacent to No. 1), Salem Place, Croydon (outside No. 27), Stretton Road, East Croydon (outside No. 59), Sundial Avenue, South Norwood (outside No. 38), Tanfield Road, Croydon (outside Nos. 1 and 3), and Waddon Park Avenue, Croydon (outside Nos. 77A/77B);
- (c) provide that the parking places would operate 'At Any Time';
- (d) specify, in respect of the parking places, that disabled persons' vehicles displaying in the relevant position a disabled persons' badge issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1975 or 1982, as amended, may be left therein; and
- (e) provide that certain vehicles may wait in the parking places in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc.

A copy of the Order which will come into operation on the 22nd May 2000, and of all associated Orders can be inspected during normal office hours on Mondays to Fridays inclusive until the end of 6 weeks from the date on which the Order was made, at the Enquiry Counter, "One Stop" Facility, Ground Floor, Taberner House, Park Lane, Croydon, Surrey. Copies of the Order may be obtained from the Traffic and Parking Section, Public Services and Works Department, Taberner House, Park Lane, Croydon.

Any person desiring to question the validity of the order or of any provision contained therein on the ground that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

  - (c) provide that the parking places would operate 'At Any Time';
  - (d) specify, in respect of the parking places, that disabled persons' vehicles displaying in the relevant position a disabled persons' badge issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1975 or 1982, as amended, may be left therein; and
  - (e) provide that certain vehicles may wait in the parking places in certain circumstances e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc.
