### VARIOUS ROADS IN COCKFOSTERS—INTRODUCTION OF ON-STREET PAY AND DISPLAY PARKING PLACES WESTPOLE AVENUE, GLOUCESTER GARDENS, KENT DRIVE, LEYS GARDENS, BALMORE CRESCENT, THE UNNAMED SERVICE ROAD TO REAR OF NOS. 4 TO 60 (EVEN) GLOUCESTER GARDENS AND SERVICE ROADS ALONGSIDE COCKFOSTERS ROAD—NEW WAITING RESTRICTIONS

Notice is hereby given that the Council of the London Borough of Enfield proposes to make:

(a) the Enfield (Parking Places) (Pay and Display) (Various Roads, Cockfosters) (Special Parking Area) (No. ) Order 2000;

(b) the Enfield (Waiting and Loading Restriction) (Special Parking Area) (Amendment No. ) Order 2000;

under sections 6, 45, 46, 49, 51 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Road Traffic Act 1991.

2. The general effect of the Pay and Display Parking Places Order would be to:

(a) designate on-street pay and display parking places in the streets specified in Schedule 1 to this Notice at which charges may be made by Enfield Borough Council for vehicles authorised by the Order to be left in those parking places;

(b) provide that the on-street pay and display parking places will operate for the times specified in Schedule 1 to this notice on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);

(c) specify that the vehicles which may be left in the on-street pay and display parking places shall display a valid parking ticket obtained from a parking pay and display machine;

(d) provide that the initial charge for the issue of a parking ticket will be as specified in Schedule 1 to this notice;

(e) specify that more than one hour must elapse from the initial charge period ending and removal of the vehicle from the parking place before another parking ticket shall be displayed;

(f) provide that certain vehicles may wait, free of charge, in certain circumstances, e.g., to allow persons to board or alight (maximum two minutes), to load or unload (maximum 20 minutes), motor cycles (maximum 3 hours) and vehicles left by specified disabled persons (no time limit).

3. The general effect of the Waiting and Loading Amendment Order would be to amend further the Enfield (Waiting and Loading Restriction) (Special Parking Area) Order 1994, so that:

(a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be prohibited between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedule 2 to this notice;

(b) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be prohibited between 8.30 a.m. and 9.30 a.m. and between 5.30 p.m. and 6.30 p.m. on Mondays to Fridays inclusive in the lengths of streets specified in Schedule 3 to this notice;

(c) the sale or offer for sale of goods from a vehicle in the lengths of streets referred to in sub-paragraphs (a) and (b) above would be prohibited, except on a Sunday, unless there is in force a valid licence issued by Enfield Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;

(d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, in the lengths of streets referred to in sub-paragraphs (a) and (b) above, would be prohibited.

4. The prohibitions referred to in sub-paragraphs 3(a) and 3(b) above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform or a parking attendant or in certain circumstances, e.g., the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc.

6. Copies of the proposed Orders, the Order being amended and the Council's statement of reasons for proposing to make the Orders, together with a plan showing the locations, can be inspected during normal office hours on Monday to Fridays inclusive at the Reception Desk, "B" Block, Civic Centre, Silver Steet, Enfield, Middlesex EN1 3XD.

7. Any person desiring to object to the proposed Orders or make other representation should send a statement in writing of either their objection and the grounds thereof or of their representation to the

Assistant Director (Operational Services), Civic Centre, Silver Street, Enfield, Middlesex EN1 3XD, quoting the reference ML/TG52/730 by 7th June 2000.

8. Under the Local Government (Access to Information) Act 1985, many of the reports made to a Committee of the Council are open to the press and to the public. When this happens any documents used to a material extent in compiling the report are also open to inspection. This means that any letter you write to the Council in response to this notice may be available to the press and to the public, who would be entitled to take copies of it if they wish.

#### SCHEDULE 1

##### *Designation of on-street pay and display parking places*

Pay and Display 9 a.m. to 5.30 p.m. Mondays to Saturdays inclusive, any such day not being Christmas Day, Good Friday or a Bank Holiday. Charges: 20p for 30 minutes; 40p for 60 minutes; 80p for 2 hours; £1.50 for 3 hours (maximum stay).

*Mount Pleasant*, the north-west side, from a point 18.3 metres south-west of the south-western kerb-line of Cockfosters Parade south-westwards for a distance of 15 metres.

*Mount Pleasant*, the south-east side, from a point 18.3 metres south-west of a point opposite the south-western kerb-line of Cockfosters Parade south-westwards for a distance of 22 metres.

*The Service Road Fronting Cockfosters Parade, Cockfosters Road*, the south-west side, from a point opposite the party wall of Nos. 2 and 3/4 Cockfosters Parade, Cockfosters Road south-eastwards for a distance of 60 metres.

*The Service Road Fronting Cockfosters Parade, Cockfosters Road*, the south-west side, from a point opposite the south-eastern wall of Nos. 13 to 18 Northside House, Cockfosters Parade, Cockfosters Road north-westwards for a distance of 25 metres.

*The Service Road Fronting Cockfosters Parade, Cockfosters Road*, the north-east side, from a point 1.5 metres south-east of a point opposite the party wall of Nos. 12 and 13 Cockfosters Parade, Cockfosters Road north-westwards for a distance of 50 metres.

*The Service Road Fronting Nos. 98 to 114 Cockfosters Road and Station Parade, Cockfosters Road*, the north-east, east and south-east side, from a point opposite the north-eastern wall of No. 114 Cockfosters Road to a point opposite the party wall of Nos. 11 and 12 Station Parade, Cockfosters Road.

*The Service Road Fronting Station Parade, Cockfosters Road*, the south-east side, from a point opposite the party wall of Nos. 13 and 14 Station Parade, Cockfosters Road to a point opposite the party wall of Nos. 26 and 27 Station Parade, Cockfosters Road.

*The Service Road Fronting Nos. 98 to 114 Cockfosters Road*, the north-west side, from a point opposite the party wall of Nos. 102 and 104 Cockfosters Road north-eastwards for a distance of 30 metres.

*The Unnamed Service Road Lying to the North-West and West of Nos. 98 to 114 Cockfosters Road*, the south-west side, from a point 6 metres south-east of a point opposite the north-western kerb-line of the service road fronting Nos. 98 to 114 Cockfosters Road north-westwards for a distance of 29 metres.

*The Unnamed Service Road Lying to the North-West and West of Nos. 98 to 114 Cockfosters Road* (and connected at its south-eastern end with the service road fronting Station Parade, Cockfosters Road), the north-east side, from a point 23 metres north-west of the north-western kerb-line of the service road fronting Nos. 98 to 114 Cockfosters Road for a distance of 5 metres.

*The Service Road Fronting Garage and The Trent Tavern, Cockfosters Road*, the south-west side, from a point 14 metres south-east of a point opposite the south-eastern wall of No. 27 Station Parade, Cockfosters Road south-eastwards for a distance of 65 metres.

*The Service Road Fronting Garage and The Trent Tavern, Cockfosters Road*, the north-east side, from a point 38 metres north-west of a point opposite the common boundary of No. 18 Cockfosters Road and The Trent Tavern, Cockfosters Road north-westwards for a distance of 11 metres.

*The Service Road Fronting Garage and The Trent Tavern, Cockfosters Road*, the north-east side, from a point 1.5 metres north-west of a point opposite the common boundary of No. 18 Cockfosters Road and The Trent Tavern, Cockfosters Road north-westwards for a distance of 25 metres.

*Cockfosters Road*, the north-east side, from a point 4.5 metres north-west of a point opposite the party wall of Nos. 3 and 4 Station Parade, Cockfosters Road south-eastwards for a distance of 40 metres.
