STOPPING-UP OF A HIGHWAY

Notice is hereby given that Hartlepool Borough Council, the Highway Authority, intends to apply to the Magistrates' Court sitting at the Law Courts, Victoria Road, Hartlepool, on Tuesday, 11th July 2000, at 2.15 p.m., for an Order, pursuant to section 116 of the Highways Act 1980, that the length of highway footpath referred to in the Schedule hereto be stopped up on the ground that it is unnecessary. Footpath, Oxley Street, Hartlepool

The length of footpath to be stopped up is located on the southern side of Oxley Street and commences at the tangent point of the kerb-line with Murray Street. It then travels in an easterly direction for a distance of approximately 14.5 metres. The width of the footpath is approximately 2 metres.

THE A43 TRUNK ROAD (WHITFIELD TURN TO BRACKLEY HATCH DUALLING SIDE ROADS) ORDER 2000

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he has made the following Order:

An Order, under sections 12, 14 and 125 of the Highways Act 1980, entitled The A43 Trunk Road (Whitfield Turn to Brackley Hatch Dualling Side Roads) Order 2000, which:

1. authorises him to:
 - (a) improve, raise, lower or otherwise alter highways;
 - (b) stop up highways;
 - (c) construct new highways;
 - (d) stop up private means of access to premises; and
 - (e) provide new means of access to premises;
 all in the parishes of Whitfield and Syresham in the county of Northamptonshire, and
2. provides for the transfer of each new highway to the County Council of Northamptonshire as highway authority specified for it in the Order from the date on which he notifies them that it has been completed and is open for traffic.

Any person aggrieved by the Order mentioned in this notice who desires to question its validity, or the validity of any provision in it, on the ground that:

- (i) it is not within the powers of the Highways Act 1980, or
- (ii) any requirement of that Act or of regulations made under that Act has not been complied with in relation to that Order

may apply to the High Court within 6 weeks from the date of first publication of this notice. On such an application, the Court may suspend or quash that Order or any provision in it.

THE A452 TRUNK ROAD (CHESTER ROAD/LITTLE ASTON ROAD IMPROVEMENT SIDE ROADS) ORDER 20

THE A43 TRUNK ROAD (WHITFIELD TURN TO BRACKLEY HATCH DUALLING) COMPULSORY PURCHASE ORDER (PS NO. 12) 2000

Notice is hereby given that the Secretary of State for the Environment, Transport and the Regions in exercise of the powers conferred on him by the above-mentioned Acts, on 10th May 2000, made a Compulsory Purchase Order, entitled as above.

The Order as made provides for the purchase of the land and rights described in the Schedule hereto for the purposes of:

- (i) the construction of a new trunk road between Whitfield Turn and Brackley Hatch in the Parishes of Whitfield and Syresham in the District of South Northamptonshire in the county of Northamptonshire in pursuance of the A43 Trunk Road (Whitfield Turn to Brackley Hatch Dualling and Slip Roads) Order 1995;
- (ii) the construction and improvement of highways and the provision of new means of access to premises in the said district and county in pursuance of the A43 Trunk Road (Whitfield Turn to Brackley Hatch Dualling Side Roads) Order 2000;
- (iii) the improvement of the A43 Trunk Road in the said district and county;
- (iv) the diversion of watercourses and the execution of other works on watercourses in connection with the construction of the new trunk road, the construction and improvement of the other highways and the execution of other works mentioned above;
- (v) the use by the Secretary of State in connection with such construction and improvement of highways and the execution of other works mentioned above; and
- (vi) the mitigation of adverse effects which the existence or use of certain of the highways proposed to be constructed or improved by the Secretary of State as mentioned above will have on their surroundings.
