NOTICE OF APPLICATION FOR CONSENT IN PURSUANCE OF SCHEDULE 10

Notice is hereby given, in accordance with Schedule 10 of the Water Resources Act 1991, as amended by the Environment Act 1995, that an application has been made to the Environment Agency by Marconi Caswell Ltd for consent to discharge trade effluent and sewage effluent. The application is for a variation of consent to discharge up to a maximum of 105 cubic metres per day of treated trade effluent comprising waste water from semi-conductor and related processing and cooling water bleed plus treated sewage effluent from premises at Marconi Caswell, Caswell, Towcester, Northamptonshire into a tributary of Caswell Brook, itself a tributary of the River Tove at National Grid Reference SP 6495 5077.

This is an existing discharge and no increase in volume is proposed. It has come to our attention that some substances detectable in the effluent or used in the works are currently not regulated by the consent. This application is to allow limits to be imposed on such substances to protect the water quality in the receiving watercourses. The trade effluent component of the discharge comprises half of the volume.

Caswell is within the South Northamptonshire District Council and Northamptonshire County Council areas.

The receiving watercourse has no recognised uses. The downstream watercourse, Caswell Brook, has the uses of moderate amenity, livestock watering and river ecosystem 4.
