NOTICE OF AMENDMENT TO A PERMANENT RESTRICTION

On 14th November 2000, Denbighshire County Council made an Order, under sections 84(1) and (2) of the Road Traffic Regulations Act 1984, the effect of which is that no person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the specified in the Schedule to this notice.

A copy of the Order, which will come into force on Monday, 20th November 2000, together with a map showing the length of road to which the Order relates, may be examined at St. Asaph Library, The Roe, St. Asaph, and at Russell House, Churton Road, Rhyl, during normal office hours.

THE A63 TRUNK ROAD (MELTON) (BRICKYARD LANE JUNCTION) (PROHIBITION OF U-TURN) ORDER

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he has made an Order, under sections 1(1) and 2(1) and (2) of the Road Traffic Regulation Act 1984, on the A63 trunk road known as Ferriby Bypass in the East Riding of Yorkshire.

The effect of the Order, which comes into operation on 17th November 2000, is as described in Issue No. 7719 of *The London Gazette* dated 16th July 1999 (Ref. 813) with the exception that at item (i), a proposal to ban the u-turn from the eastbound carriageway to the westbound carriageway and at item (ii), a proposal to ban the right-turn from Brickyard Lane into the A63 eastbound carriageway have not been included in the made Order.

THE A47 TRUNK ROAD (UPPINGHAM ROAD, SKEFFINGTON, LEICESTERSHIRE) (50 MILES PER HOUR SPEED LIMIT) ORDER 2000

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he intends to make an Order, under section 84(1)(a) and (2) of the Road Traffic Regulation Act 1984, on the A47 Trunk Road at Skeffington in the county of Leicestershire.

The effect of the Order would be to impose a 50 miles per hour speed limit on a length of the A47 Trunk Road from a point 369.5 metres west to a point 325 metres south-east of its junction with Main Street.
