THE A1 TRUNK ROAD (C107 WOOLLEY ROAD. CAMBRIDGESHIRE) (CLOSURE OF GAP IN THE CENTRAL **RESERVATION) ORDER 2000**

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he has made an Order, under sections 1(1) and 2(1) and (2) of the Road Traffic Regulation Act 1984, on the A1 Trunk Road in Cambridgeshire.

The effect of the Order, which comes into force on 24th November 2000, will be to permanently close the gap in the central reservation opposite the junction with the C107 Woolley Road.

Any person wishing to question the validity of, or of any provision

contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any Instrument made under, any provision of that Act has not been complied with in relation to the Order may, within 6 weeks of 10th November 2000, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

THE BARNET (PRESCRIBED ROUTE) (NO. 5) TRAFFIC **ORDER 2000**

Notice is hereby given that the Council of the London Borough of Barnet have made, on 15th November 2000, the above-mentioned Order under sections 6 and 124 of, and Schedule 9 to, the Road Traffic Regulation Act 1984.

- 2. The general effect of the Order will be to make permanent the width restriction in Torrington Park, London N.12, which was previously introduced under an experimental traffic order. This width restriction will prevent vehicles over 2·13 metres (7 feet) from using the roads.
- 3. The prohibitions referred to in paragraph 2 above will not apply in relation to anything done:
- (a) with the permission or at the direction of a police constable in uniform;
- (b) in accordance with traffic signs placed pursuant to section 66 or section 67 of the Road Traffic Regulation Act 1984;
- (c) in relation to any vehicle being used for ambulance, fire brigade or police purposes in an emergency;
- (d) in relation to any vehicle being used to provide a London Bus Service by virtue of an agreement with London Regional Transport made under section 3(2) of London Regional Transport Act 1984.
