#### **NOTICE OF AN APPLICATION FOR A LICENCE TO ABSTRACT WATER**

Take notice that Martin Clifton Ltd, of Priorylands, Appledore, Ashford, Kent, is applying to the Environment Agency for a licence to abstract water from the Newmill and Hexden Channels, at National Grid Reference TQ 8726 2907 and TQ 8598 2783 at Maytham Farm, Rolvenden Layne, Tenterden, Kent. The proposal is to abstract water at the following rates: 3 cubic metres per hour; 60 cubic metres per day; 15,000 cubic metres between March and September each year.
