##### ROAD TRAFFIC REGULATION ACT 1984

##### THE A1 TRUNK ROAD (GATESHEAD/NEWCASTLE WESTERN BYPASS) (BIRTLEY TO SEATON BURN) (VARIABLE SPEED LIMIT) ORDER

The Secretary of State for the Environment, Transport and the Region, hereby gives notice that he has made an Order, under sections 84(1) and (2) of the Road Traffic Regulation Act 1984, which comes into operation on 16th March 2001.

##### ROAD TRAFFIC REGULATION ACT 1984

##### THE A435 TRUNK ROAD (SPERNAL ASH, WARWICKSHIRE) (PROHIBITION OF WAITING) ORDER 200

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he intends to make an Order, under sections 1(1), 2(1) and (2) and 4(1) and (2) of the Road Traffic Regulation Act 1984, on the A435 Trunk Road at Spernal Ash in the county of Warwickshire.

The effect of the Order will be to prohibit waiting at any time on the west side of the A435 Trunk Road, from a point 18 metres north of its junction with the centre line of the A448 (Bromsgrove Road) to a point 83 metres north of that junction.

##### THE A45 TRUNK ROAD (RYTON-ON-DUNSMORE, WARWICKSHIRE) (50 MILES PER HOUR SPEED LIMIT) ORDER 2001

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he has made an Order, under sections 84(1)(a) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984, on the A45 Trunk Road at Ryton-on-Dunsmore in the county of Warwickshire.

The effect of the Order will be to impose a 50 miles per hour speed limit on:
