

- (i) from a point 490 metres north-west of its junction with the centreline of Hungry Lane, Weeford to a point 500 metres north-west of its junction with the centreline of School Lane, Hints; and  
 (ii) from a point 270 metres south-east of its junction with the centreline of Hints Lane, Hints, to a point 805 metres south-east of that junction.

An Order imposing a temporary speed restriction on these lengths of trunk road would be revoked.

#### THE A5 TRUNK ROAD (WATLING STREET, SHENSTONE, STAFFORDSHIRE) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2001

### ROAD TRAFFIC REGULATION ACT 1984

#### THE A12 TRUNK ROAD (BRENTWOOD, ESSEX) (PROHIBITION OF ENTRY) ORDER 2001

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he has made an Order, under sections 1(1) and 2(1) and (2) of the Road Traffic Regulation Act 1984, on the A12 Trunk Road at Brentwood in Essex.

The effect of the Order, which will come into force on 4th May 2001, will be to close permanently the laybys situated:

- (a) on the northbound and southbound carriageways of the trunk road between points 19 metres and 144 metres north-east of its bridge over Dodinghurst Road; and
- (b) on the southbound carriageway of the trunk road between points 47 metres and 245 metres south-west of the Spital Lane Footbridge.

Any person wishing to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any Instrument made under, any provision of that Act has not been complied with in relation to the Order may, within 6 weeks of 20th April 2001, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

Notice is hereby given that the Council of the London Borough of Brent, on 17th April 2001, made the above-mentioned Orders under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by section 8 of, and Part 1 of Schedule 5 to, the Local Government Act 1985, so as to continue in force indefinitely the provisions of the Brent (Various Roads) (No. 2) Experimental Traffic Order 1999.

2. The general effect of the "Restriction of Stopping on Bus Stops" Order will be to amend the Brent (Restriction of Waiting on Bus Stops) (No. 1) 1974 and 1977 and (Restriction of Stopping on Bus Stops) (No. 2) 1998 Traffic Orders so as to revoke certain Bus Stop Clearway Restrictions in High Road, Wembley, and prohibit all vehicles from stopping "at any time" in the bus stops which lie within the lengths of streets specified in Schedule 1 to this notice.

3. The "Waiting and Loading Restrictions" (Amendment) Order will be further to amend the Brent (Waiting and Loading Restriction) Order 1979, so that:

- (i) the hours during which the existing prohibition applies on waiting by vehicles will be changed so that such prohibition will apply at any time in the lengths of streets specified in Schedule 2 to this notice;
- (ii) the hours during which the existing prohibition applies on waiting by vehicles (including for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be changed so that such prohibition will apply at any time in the lengths of street specified in Schedule 3 to this notice;
- (iii) the hours during which the existing prohibition applies on waiting by vehicles (including for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be changed so that such prohibition will apply between 7 a.m. and 7 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedule 4 to this notice;
