- (iv) the hours during which the existing prohibition applies on waiting by vehicles (including for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be changed so that such prohibition will apply between 7 a.m and 10 a.m. and between 4 p.m. and 7 p.m. on Mondays to Saturdays inclusive in the length of street specified in Schedule 5 to this notice;
- (v) the hours during which the existing prohibition applies on waiting by vehicles (including for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be changed so that such prohibition will apply between 7 a.m. and 1 p.m. and between 4 p.m. and 7 p.m. on Mondays to Saturdays inclusive in the length of street specified in Schedule 6 to this notice
- (vi) the hours during which the existing prohibition applies on waiting by vehicles (including for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be changed so that such prohibition will apply between 7 a.m. and 10 a.m. and between 1 p.m. and 7 p.m. on Mondays to Saturdays inclusive in the length of street specified in Schedule 7 to this notice;
- (vii) waiting by vehicles (including waiting for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited at any time in the lengths of streets specified in Schedule 8 to this notice; (viii) waiting by vehicles (including waiting for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited between 7 a.m. and 10 a.m. and between 4 p.m. and 7 p.m. on Mondays to Saturdays inclusive in the length of street specified in Schedule 9 to
- (ix) waiting by vehicles (including waiting for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited between 7 a.m. and 1 p.m. and between 4 p.m. and 7 p.m. on Mondays to Saturdays inclusive in the lengths of street specified in Schedule 10 to
- (x) waiting by vehicles (including waiting for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited between 7 a.m. and 10 a.m. and between 1 p.m and 7 p.m. on Mondays to Saturdays inclusive in the length of street specified in Schedule 11 to
- (xi) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be changed so that such prohibition will apply:
- (a) at any time in the lengths of streets specified in Schedules 3 and 8 to
- (b) between 11.30 a.m and 4 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedules 5 and 9 to this notice;
- (c) between 1 p.m and 4 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedules 6 and 10 to this notice;
- (d) between 11.30 a.m. and 1 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedules 7 and 11 to this notice;
- (xii) the sale or offer for sale of goods from a vehicle will be prohibited (except on Sundays in the lengths of streets specified in Schedules 2, 3 and 8) unless there is in force a valid licence issued by the Brent Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;
- (xiii) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising will be prohibited;
- (xiv) any existing prohibition on the waiting by vehicles (including for the purpose of loading or unloading a vehicle), the sale or offer for sale of goods from a vehicle or the use of any vehicle or animal or the wearing of fancy dress or other costume wholly or mainly for the purpose of advertising, will be revoked.
- 4. The prohibitions referred to in paragraph 3 above will not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., the picking up or setting down of passengers; the carry out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Orange/Blue Badge" will apply.

 5. The general effect of the "Goods Vehicles Free Loading Places"
- Order will be to:
- (i) designate a free loading place in the length of street specified in Schedule 12 to this notice to operate between 12 midnight and 7 a.m. and between 10 a.m. and 4 p.m. and between 7 p.m. and 12 midnight Mondays to Saturdays; and on Sundays;
- (ii) specify that goods carrying vehicles constructed or adapted for use for the carriage of goods or burden of any description and is not drawing a trailer, may be used, subject to the provisions of the Order, for the purpose of continuous loading and unloading during the permitted hours.
- 6. The prohibitions referred to in paragraph 5 above will not apply in respect of anything done with the permission or at the direction of a police constable in uniform.

- 7. A copy of each of the Orders, which will come into operation on 1st May 2001, of a map of the relevant area, of the Brent (Waiting and Loading Restriction) Order 1979 (and of the Orders which have amended that Order), of the Brent (Restriction of Waiting on Bus Stops) (No. 1) Traffic Order 1974 and 1977 (and of the Orders which have amended these Orders) and of the Brent (Restriction of Stopping on Bus Stops) (No. 2) Traffic Order 1998 can be inspected, during normal office hours on Mondays to Fridays inclusive until the end of 6 weeks from the date on which the Orders were made, at:
- (a) The One Stop Shop, Brent Town Hall, Forty Lane, Wembley, Middlesex HA9 9HX; and
- (b) The One Stop Shop, Brent House, 349-357 High Road, Wembley, Middlesex HA9 6BZ.
- 8. Copies of the Orders may be purchased from the address mentioned in paragraph 7(b) above.
- 9. Any person desiring to question the validity of any of the Orders or of any provisions contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to any of the Orders may, within 6 weeks of the date on which the Orders were made, make application for the purpose to the High Court.
