#### LONDON BRIDGE ZONE F

Notice is hereby given that the Council of the London Borough of Southwark proposes to make the above-mentioned Order under sections 6, 45, 46, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and of all other powers thereunto.

The general effect of the Order would be to consolidate the regulations contained within The Southwark (Parking Places) Zone F) London Bridge Area Traffic Order (No. 1) 1999 and The London Borough of Southwark (Waiting & Loading Restrictions) (Amendment No. 123)
