ROAD TRAFFIC REGULATION ACT 1984

THE A16 TRUNK ROAD (DEEPING ST. NICHOLAS, LINCOLNSHIRE) (50 MILES PER HOUR SPEED LIMIT) ORDER 200

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he intends to make an Order under sections 84(1)(a) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984, on the A16 Trunk Road at Deeping St. Nicholas in the county of Lincolnshire.

The effect of the Order would be to extend the existing 50 miles per hour speed limit on the A16 trunk road (known as Littleworth Drove) at Deeping St. Nicholas, imposing a 50 miles per hour spped limit from a point 430 metres north-east of its junction with Green Lane to a point 750 metres north-east of its junction with the B1525.

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14(1)(A) AND 15(2)

THE A446 TRUNK ROAD (B4114 BIRMINGHAM ROAD—M6 MOTORWAY JUNCTION 4) (TEMPORARY RESTRICTION AND PROHIBITION OF TRAFFIC) ORDER 2001

Notice is hereby given that the Secretary of State for the Environment, Transport and the Regions has made an Order on the A446 Trunk Road in Warwickshire allow work to be carried out safely in connection with the construction of the Birmingham Northern Relief Road and work to be carried out to Bacons End Bridge on Birmingham Road.

The effect of the Order will be to:

(a) impose a 50 miles per hour speed limit on the A446 Stonebridge Road from its junction with the B4114 Birmingham Road to its junction with the northbound exit slip road from the M6 Motorway at Junction 4;

(b) close the layby adjacent to the southbound carriageway of the A446 situated opposite Coleshill Heath Road;

(c) prohibit vehicles from making a right turn from Coleshill Heath Road through the gap in the central reservation onto the southbound carriageway of the A446;

(d) prohibit vehicles from making a right turn from the A446 through the gap in the central reservation into Coventry Road; and

(e) prohibit vehicles proceeding in the northbound or southbound carriageway of the A446 from making a U-turn through the gaps in the central reservation opposite Coleshill Heath Road; Wheeley Moore Farm and Coventry Road.

Work is expected to start on Tuesday, 8th May 2001 and continue for approximately eighteen months. The Order will come into force on 4th May 2001.

Diversion routes will be well signed.

Vehicles being used for police, fire brigade, or ambulance purposes will be exempt from the right turn bans, U-turn bans and the speed limit and vehicles being used in connection with the works will be exempt from the layby closure.
