

# TRAFFIC MANAGEMENT ORDER

The Council of the London Borough of Southwark, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by section 6 of the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985 and of all other powers thereunto enabling, hereby make the following Order:

1. This Order shall come into operation on 29th May 2001, and may be cited as the Southwark (Prescribed Route) Traffic Management Order 2001.

2. No person causing any vehicle to proceed northbound in Rye Lane shall cause that vehicle to turn right into Peckham High Street.

3. Nothing in Article 2 of this Order shall apply to:

(a) anything done with the permission or at the direction of a police constable in uniform:

(b) to any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to section 66 or 67 of the Road Traffic Regulation Act 1984.

THE LONDON BOROUGH OF SOUTHWARK (BUS LANE) EXPERIMENTAL TRAFFIC MANAGEMENT ORDER 2001/034 NOTICE OF PROPOSAL TO MAKE A TRAFFIC MANAGEMENT ORDER

Notice is hereby given that the Council of the London Borough of Southwark proposes to make the above-mentioned Order under sections 9 and 124 of, and Part IV of Schedule 9 of, the Road Traffic Regulation Act 1984

The general effect of this Order will be to provide a bus lane on the east side of Waterloo Road, between a point 5 metres south of Baron's Place and extending to a point 156 metres south, 7 a.m. to 7 p.m. Monday to Saturday.

Nothing specified in Article 2 of this Order shall apply to: a bus, local bus, tram, or pedal cycle; an ambulance, fire brigade or police purposes; anything done in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police; it being used with the permission or at the direction of a police constable in uniform or a traffic warden; the service of a local authority for the purpose of collecting refuse; the pursuance of any statutory duty of the Post Office for the purpose of collecting or delivering letters provided the vehicle bears the Royal Mail livery.

A copy of the proposed Order, which will come into operation on 22nd May 2001, plans indicating the lengths of road affected and the Council's statement of reasons for making the Order can be inspected, on Mondays to Fridays inclusive during normal office hours, until the expiration of a period of 18 months from the date on which this notice is published.
