Notice is hereby given that Greenwich Council, hereinafter called the Council, propose to make the above-mentioned Order under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.

The general effect of the Order would be to amend the operational hours of the existing waiting and loading restrictions to now operate

- (a) between 8 a.m. and 6.30 p.m. on Mondays to Saturdays and between 9 a.m and 6.30 p.m. on Sundays or between 9 a.m. and 6.30 p.m. on Mondays to Sundays inclusive on certain lengths of the roads situated within the proposed East Greenwich CPZ;
- (b) between 7 a.m. and 7 p.m. or between 8 a.m. and 6.30 p.m. or between 9 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive on certain lengths of the roads situated within the proposed Charlton-Westcombe CPZ:
- (c) at any time, at the junctions of certain roads situated within the proposed East Greenwich CPZ and the proposed Charlton-Westcombe CPZ.

The full details and effects of these controlled parking zones were displayed at the public exhibition held at "The Forum@Greenwich", Trafalgar Road, between Monday, 5th February 2001 and Saturday, 10th February 2001 inclusive.

London Borough of Newham THE NEWHAM (PRESCRIBED ROUTE) (NO. 3) ORDER 2001 ABBEY LANE
