**PUBLIC NOTIFICATION OF AN APPLICATION MADE UNDER SECTION 11 OF THE ENVIRONMENTAL PROTECTION ACT 1990, PART I**

#### **INTEGRATED POLLUTION CONTROL**

Notice is hereby given that International Coatings Ltd. has applied to the Environment Agency for a major variation to the Integrated Pollution Control Authorisation AK5598 to enable batch production of a polycondensate, copper acrylate resin. This process includes the reduction of waste streams by incorporating solvent recovery by distillation at Stoneygate Lane, Felling, Gateshead, Tyne and Wear NE10 0JY, in the borough of Gateshead, in the county of Tyne and Wear.

Information relating to the above IPC variation for authorisation to enable batch production of a polycondensate copper acrylate resin is held in registers at the following locations:

Environment Agency Area Office, Tyneside House, Skinnerburn Road, Newcastle Business Park, Newcastle upon Tyne NE4 7AR; and Gateshead Metropolitan Borough, Civic Centre, Regent Street, Gateshead, Tyne and Wear NE8 1HH.

Members of the public can inspect these registers, free of charge, at the above stated addresses during normal office hours. In addition, members of the public who wish to obtain a copy of the relevant information contained in the registers can do so upon the payment of a reasonable charge to cover the costs of copying.

Any such objections or representations will be entered into a public register unless the person making them requests in writing that they should not be so placed. If there is such a request, the register will only include a statement that there has been a request.

#### **CLIFF STABILISATION/PROTECTION WORKS AT COASTGUARD COTTAGES, CAWSAND**

The Caradon District Council, acting in their capacity as coast protection authority, hereby give notice, under subsection (i) of section 5 of the above Act, that they propose to carry out coast protection works as described herein at Coastguard Cottages, Cawsand.

The work will consist of:

Construction of reinforced gunite retaining wall at the base of the cliff anchored to the competent bedrock.

Make up ground in middle section of the cliff with well graded backfill. Stabilise top of the cliff with mesh and soil nails.

Reinstate area to original.

The estimate cost of the work is £170k.

Any person may, not later than 6th June 2001, serve a written notice of objection to the above proposal on the Minister of Agriculture, Fisheries and Food and on the above-mentioned authority. #### **NOTICE OF APPLICATION TO VARY A LICENCE TO ABSTRACT WATER**

Take notice that Silsden Golf Club, of High Brunthwaite, Silsden, Keighley, is applying to the Environment Agency to vary licence serial number 2/27/15/267, which authorises the abstraction of water from a borehole in the Millstone Grit, at National Grid Ref. SE 055 460, at Silsden Golf Club, High Brunthwaite, Silsden, Keighley BD20 0ND.

The variation being applied for is to increase the annual and daily quantities from (1) 4.9 cubic metres per day May to October (2) 0.45 cubic metres annually, 54 cubic metres per day to (1) 4.9 cubic metres May to October (2) 2.993 cubic metres annually and 61 cubic metres per day, the hourly rate remains the same.
