NOTICE OF APPLICATION FOR CONSENT IN PURSUANCE OF SCHEDULE 10 (AS AMENDED BY THE ENVIRONMENT ACT 1995)

Notice is hereby given, in accordance with Schedule 10 of the Water Resources Act 1991 (as amended by the Environment Act 1995), that an application has been made to the Environment Agency, Anglian Region, by Anglian Water Services Ltd for consent to discharge up to 69,120 cubic metres per day of secondary treated sewage effluent and storm sewage effluent from their Ingoldmells STW via a long sea outfall into the North Sea at National Grid Reference TF 5966 6897. The improved treatment at this site fulfills Anglian Water Services obligations to provide secondary treatment to Urban Waste Water Treatment Directive standards by 31 December 2001.

Any person who wishes to make representations about the application should do so in writing to the Environment Planning Manager (Northern Area), Environment Agency, Waterside House, Waterside North, Lincoln LN2 5HA, to arrive not later than 21 August 2001, quoting Reference No ANNCS3740/13577.

A copy of the application may be inspected, free of charge, at the offices of the Environment Agency, Guy Gibson Hall, Manby Park, Louth, Lincolnshire LN11 8UR at all reasonable hours.

The Environment Agency is committed to maintaining and, where possible, improving water quality. If, after full consideration of this application and any representations made by interested parties, it is decided that consent can be given, then conditions will be imposed to ensure that the effluent receives treatment before discharge to the receiving waters so that the above aims are met.
