THE HOTON FIELD

Pursuant to Regulation 5(8) of the above Regulations, the Secretary of State for Trade and Industry gives notice that, being content that the requirements of the above Regulations have been satisfied, he has pursuant to Licence P.001 granted a consent to BP Exploration Operating Company Limited to the getting of petroleum and the construction of installations in relation to the development of the Hoton gas field. The consent for the Hoton field took effect from 9 July 2001. BP Exploration Operating Company Limited propose to re-enter a single existing well and drill a new multilateral sidetrack in blocks 48/6 and 48/7b of the UKCS. Due to the production of proppant from the original bore, which needs to be separated from the gas as soon as possible due to its abrasive nature, a Normally Unmanned Installation
