**NOTICE OF APPLICATION FOR A LICENCE TO ABSTRACT WATER**

Take notice that Skanska UK Civil Engineering Ltd, of Maple House, Denham Way, Maple Cross, Rickmansworth, Hertfordshire is applying to the Environment Agency for a licence to abstract water from the River Sence and Burton Brook between National Grid Ref SP 6534 9727/SP 6536 9734 and SP 6706 9591/SP 6759 1590 respectively at Great Glen, Leicestershire.

The proposal is to abstract water at the following rates: 18 cubic metres per hour, 182 per cubic metres per day, 15,015 cubic metres between May and September each year. No more than 10,010 cubic metres will be abstracted from the River Sence and no more than 5,005 cubic metres will be abstracted from the Burton Brook each year.

The water will be used for dust suppression during the construction of the Great Glen Bypass.

A copy of the application and any maps, plans and any other documents submitted with it may be inspected, free of charge, at all reasonable hours at the Site Offices, near Burton Lodge Farm, London Road, Great Glen, Leicestershire between 24 July 2001 and 24 August 2001.

**NOTICE OF APPLICATION FOR CONSENT IN PURSUANCE OF SCHEDULE 10**

Notice is hereby given, in accordance with Schedule 10 of the Water Resources Act 1991 (as amended by the Environment Act 1995), that an application has been made to the Environment Agency by Anglian Water Services Limited for consent to discharge sewage in emergency conditions from Chapel Lane Terminal Pumping Station into tributary of the River Tud. The discharge point will be at National Grid Ref Point TG 0780 1296 within the Breckland District Council area. The terminal pumping station is being constructed to pass flows to the Sewage Treatment Works. The overflow from the pumping station is predicted to operate less than once a year.

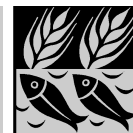

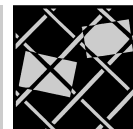
