#### NOTICE OF THE ISSUE OF A SUBMARINE PIPE-LINE WORKS AUTHORISATION

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by BHP Petroleum whose address is 1 Neathouse Place, London SW1V 1LH, for the construction of a pipeline system between the Hamilton East subsea wellhead structure and the Hamilton North Platform.

Except with the consent of the Secretary of State, the 258.5 Millimetre, Gas Production pipeline shall only be used to convey untreated natural gas; and the chemical injection umbilical shall only be used to convey methanol, gas, brine and injection chemicals.

The pipe-lines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

BHP Petroleum has been appointed operator of the pipe-lines.

#### NOTICE OF APPLICATION FOR A LICENCE TO ABSTRACT WATER

Take notice that Skanska UK Civil Engineering Ltd, of Maple House, Denham Way, Maple Cross, Rickmansworth, Hertfordshire, is applying to the Environment Agency for a licence to abstract water from the River Sence and Burton Brook between National Grid references SP 6534 9727/SP 6536 9734 and SP 6706 9591/SP 6715 9590 respectively at Great Glen, Leicestershire.

The proposal is to abstract water at the following rates: 18 cubic metres per hour, 182 cubic metres per day, 15,015 cubic metres between May and September each year. No more than 10,010 cubic metres will be abstracted from the River Sence and no more than 5,005 cubic metres will be abstracted from the Burton Brook each year.

The water will be used for dust suppression during the construction of the Great Glen Bypass.
