The effect of the Order would be to impose a 30 mph speed limit on the A259 (Winchelsea Road) at Guestling Green, between points 240 metres south and 270 metres north of its junction with Chapel Lane, a total

distance of approximately 510 metres.

Notice is hereby given that the Council of the Royal Borough of Kingston upon Thames on 30 August 2001 made the above-mentioned Orders under sections 6, 84 and 124 of the Road Traffic Regulation Act 1984, (as amended).

1. The general effect of the Orders, which will come into operation on 10 September 2001, would be:

(a) to introduce a 20 mph speed limit on those roads and lengths of road specified in the Schedule to this notice.

(b) to further amend the Kingston upon Thames (Waiting and Loading Restriction) (Special Parking Area) (No 1) Traffic Order 1994, so that: (i) the present waiting restrictions (otherwise than for loading and unloading a vehicle) at the junctions of Penrith Road, Montem Road, Cleveland Road and Connaught Road with Kingston Road would be upgraded to apply "At Any Time"

(ii) the present waiting restrictions at the junction of Grafton Road,

Cambridge Road and Sussex Road with High Street would be upgraded to apply "At Any Time" for 20 metres.

(iii) in Cambridge Road 10 metre waiting restrictions would be introduced to apply "At Any Time" at its junctions with Avenue Road, Connaught Road, Cleveland Road, Montem Road and Penrith Road. The restrictions would extend 10 metres into each of these roads

The restrictions would extend 10 metres into each of these roads. (iv) in Grafton Road 10 metre waiting restrictions would be introduced to apply "At Any Time" at its junction with Avenue Road extending for 10 metres into Avenue Road, and at its junction with Cleveland Road "At Any Time" waiting restrictions will extend for 10 metres on the south side and for 30 metres on the north side. (v) in Avenue Road, 10 metre "At Any Time" waiting restrictions will be introduced at the junction with Tregaron Gardens.

(vi) in Connaught Road 10 metre "At Any Time" waiting restrictions will be introduced at its junction with Sussex Road extending for 10 metres into Sussex Road.

(vii) in Cleveland Road "At Any Time" waiting restrictions will be introduced at the junction with Grafton Road to extend for 10 metres on the east side and 15 metres on the west side;

(viii) the loading restrictions in Cambridge Road will be extended to 20 metres from the High Street, in Grafton Road will be reduced on the south-east side to 10 metres from the High Street, and will be introduced in Sussex Road for 20 metres from the High Street.

Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or that any of the relevant regulations made thereunder have not been complied with in relation to the Order may, within 6 weeks of the making of the Order, make application for the purpose to the High Court.
