THE A36 TRUNK ROAD (KNOOK) (40 MPH AND 50 MPH SPEED LIMIT) ORDER 200

The Secretary of State for Transport, Local Government and the Regions hereby gives notice that he proposes to make an Order under section 84(1) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984 on the A36 Trunk Road at Knook in the district of West Wiltshire in the county of Wiltshire.

The effect of the Order would be to impose:

(a) a 40 miles per hour speed limit on the A36 Trunk Road for a distance of 940 metres from a point 380 metres north-west of the junction with the C280 Manor Road to Upton Lovell to a point 116 metres north-west of the junction with the unclassified road to Knook village; and
