THE CAMDEN (WAITING AND LOADING RESTRICTIONS) (SPA) (AMENDMENT NO 78) TRAFFIC ORDER 2001 THE CAMDEN (WAITING AND LOADING RESTRICTIONS) (SPA) (AMENDMENT NO 83) TRAFFIC ORDER 2002

Notice is hereby given, that the Council of the London Borough of Camden on 8 March 2002 made the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Road Traffic Act 1991, the details as previously published in *The* London Gazette on 19 October 2001 and 25 January 2002, under Ref Nos 504 and 822 respectively.

The general effect of the (Waiting and Loading) (Amendment 78) Order, in part will be to introduce additional "at any time" waiting restrictions at and around the junctions of Willes Road/Inkerman Road and extend the existing double yellow line in Grafton Road, just north of Kiln Place

The general effect of the (Waiting and Loading) (Amendment 83) Order will be to:

- (i) Introduce double yellow "at any time" waiting restrictions on the south-west side of Chalk Farm Road, between Camden Lock Place and
- a point opposite Hawley Street;
  (ii) introduce double yellow "at any time" waiting and loading restrictions on the north-east side of Maida Vale at the junction with Greville Place:
- (iii) introduce double yellow "at any time" waiting restrictions on the north-east side of Haverstock Hill and on both sides of Ornan Road between the junctions with Haverstock Hill for a distance of 14.8 metres in a south-west direction;
- (iv) introduce double yellow "at any time" waiting restrictions outsideNo 50 Weavers Way for a distance of 14.5 metres in an easterly direction;
- (v) introduce double yellow "at any time" waiting restrictions in York Rise, across the vehicle entrance of Faraday House for a distance of
- (vi) introduce double yellow "at any time" waiting restrictions in St Alban's Road junctions with Croftdown Road and Brookfield Park and in Brookfield Park junctions with St Alban's Road and Swain's Lane.

THE CAMDEN (DISABLED PERSONS) AND (DEDICATED PERMIT PARKING PLACES) (AMENDMENT NO 17) TRAFFIC
