##### THE GUILDFORD OFF-STREET PARKING PLACES (AMENDMENT) (NO 1) ORDER 2002

Notice is hereby given that Guildford Borough Council has made an Order in exercise of its powers under sections 32, 33, 35 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (as amended) the effect of which will be to amend the Guildford Off Street Parking Places Consolidation and Amendment Order 1996 (as amended) by ceasing to make provision for contract car parking at 'Bedford Road Multi-Storey Car Park (Level 2 Contract Areas), Guildford.

REASON. The Order has been made to enable the provision of contract car parking to be discontinued in the designated parts of the above car park.

NOTE. The Order will come into effect on 1 April 2002.

A copy of the Order may be inspected at Guildford Borough Council Offices, Millmead House, Millmead, Guildford, on Mondays to Fridays between the hours of 9.00 am and 4.30 pm.

If you wish to question the validity of the Order or of any other provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on any grounds that any requirement of the Act or of any Instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 29 March 2002, apply to the High Court for this purpose.
