**WILLESDEN CPZ—MW (EXTENSION) AND MA (INCLUDING CHANGES)**

1. Notice is hereby given that the Council of the London Borough of Brent on 3 April 2002, made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by section 8 of and Part I of Schedule 5 to the Local Government Act 1985, the Parking Acts of 1986 and 1989 and the Road Traffic Act 1991.

2. The general effect of the "Disabled Persons Parking Places" Order will be to:

- (a) designate a disabled person parking place in Dartmouth Road in which vehicles authorised by the Order may be left for any period without charge;
- (b) provide that the parking place will operate "at any time";
- (c) specify, in respect of the parking place, that disabled persons' vehicles displaying in the relevant position a disabled person's badge (commonly referred to as "the Orange or Blue Badge") issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 may be left therein; and
- (d) provide that certain vehicles may wait in the parking place in certain circumstances, eg to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc.

3. The general effect of the "Parking Places" Order will be to:

- (a) designate parking places that will operate:
  - (i) between 10.00 am and 3.00 pm on Mondays to Fridays in certain lengths of the streets specified in Schedules 1 and 2 to this notice (MA Zone);
  - (ii) between 8.00 am and 6.30 pm on Mondays to Saturdays in certain lengths of the streets specified in Schedules 4 and 5 to this Notice (MW Zone);
- (b) specify that:
  - (i) each parking place may be used, subject to the provisions of the Order, for the leaving during the permitted hours of such vehicles as are passenger vehicles, goods carrying vehicles or invalid carriages displaying a valid parking ticket or permit. Motor cycles park free;
  - (ii) the maximum initial period for which a vehicle, displaying a valid parking ticket may be left during the permitted hours in the parking places specified in Schedules 1 and 4 to this notice will be 4 hours;
  - (iii) the charge for short term parking in the parking places specified in Schedules 1 and 4 to this notice will be 10 pence for 20 minutes, 20 pence for 40 minutes, 60 pence for 1 hour, £1.20 for 2 hours and £2.40 for 4 hours, the tickets for which will be issued by pay and display meters;
  - (iv) the interval before a vehicle may again be left in a parking place after the expiration of the period for which the initial charge was incurred will be 2 hours;

(v) any resident whose usual place of abode is in any street specified in Schedules 3 and 6 to this notice may apply to the Council for the issue of a residents permit valid for use in the parking places specified in Schedules 1, 2, 4 and 5 to this notice;

(vi) a maximum of 3 permits per residential postal address will be issued by the Council or its agents, to persons whose usual place of abode is in any street specified in Schedules 3 and 6 to this notice. The charges will be £50 per annum (£25 if the vehicle engine size is less than 1100cc) or £31 for six months (£15.50 if the vehicle engine size is less than 1100cc) for the first permit, £75 per annum (£43.50 for six months) for the second permit and £100 per annum (£56 for six months) for the third permit. Unexpired permits that have been paid for and surrendered to the Council will be entitled to a refund of one twelfth of the charge paid (one sixth for 6 months permits) in respect of each unexpired month, subject to a maximum refund of 3 months;

(vii) any resident whose usual place of abode is in any street or part of street specified in:

(a) Schedule 3 to this notice may apply to the Council for the issue of visitor's permits valid for the period between 10.00 am and 3.00 pm, Mondays to Fridays;

(b) Schedule 6 to this notice may apply to the Council for the issue of visitor's permits valid for the period between 8.00 am and 6.30 pm, Mondays to Saturdays;

up to a maximum of 150 per annum per residential postal address at a cost of 50 pence per permit per day of use. Unlimited additional visitors permits issued to the same residential postal address cost one pound per permit per day of use;

(viii) any resident whose usual place of abode is in any street or part of street specified in:

(a) Schedule 3 to this notice may apply to the Council for the issue of a householder visitor permit valid for use in the street for which it is issued for the period between 10.00 am and 3.00 pm, Mondays to Fridays;

(b) Schedule 6 to this notice may apply to the Council for the issue of a household visitor permit valid for use in the street for which it is issued for the period between 8.00 am and 6.30 pm, Mondays to Saturdays;

at a cost of £75 per annum;

(ix) any person who occupies premises in any street specified in Schedules 3 and 6 to this notice and who uses such premises for non-residential purposes may apply to the Council for the issue of a general business permit valid for use in the parking places specified in Schedules 1, 2, 4 and 5. The charge for each general business permit will be £250 per annum (£131 for 6 months, £70 for 3 months);

(x) any person who occupies premises in any street specified in Schedules 3 and 6 to this notice and who uses such premises for non-residential purposes may apply to the Council for the issue of a liveried vehicle business permit for any of its vehicles marked with the company livery for use in the parking places specified in Schedules 1, 2, 4 and 5. The charge for each liveried vehicle business permit will be £150 per annum (£81 for 6 months, £45 for 3 months);

(xi) permits issued by the Council to essential users will be valid for use in all the parking bays provided for resident and business users in the MA and MW zones;

(xii) any resident of a "car free" development as defined in a section 106 agreement made under the Town and Country Planning Act 1990 will not be eligible for a residents permit in the MA and MW zones.

4. The general effect of the "Waiting and Loading Restrictions" Order will be to further amend the Brent (Waiting and Loading Restriction) Order 1979, so that:

(a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited "at any time", between 8.00 am and 6.30 pm on Mondays to Fridays or Mondays to Saturdays or between 10.00 am and 3.00 pm on Mondays to Fridays in certain lengths of the streets specified in Schedule 7 to this notice;

(b) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be prohibited between 11.00 am and 6.30 pm throughout the week, between 11.00 am and 6.30 pm on Mondays to Fridays or Mondays to Saturdays or between 11.00 am and 3.00 pm on Mondays to Fridays in certain lengths of the streets specified in Schedule 7 to this notice;

(c) the sale or offer for sale of goods from a vehicle will be prohibited unless there is in force a valid licence issued by the Brent Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;

(d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, will be prohibited;
