Kensington, June 27.

AN humble Address of the Lieutenant Governour, Council and Assembly of the Island of Antigua met at the Town of St. John's, having been transmitted hither, has been presented to His Majesty by their Agent, being introduced by the Right Honourable James Craggs, Esq; one of His Majesty's Principal Secretaries of State.

An humble Address of the President and Council, and of the Assembly of the Island of Nevis, assembled at Charles Town in the said Island on the 12th of March last, having been transmitted hither, has been presented to His Majesty by Collonel Daniel Smith their Lieutenant-Governour, and Joseph Jory, Esq; their Agent, being introduced by the Right Honourable James Craggs, Esq; one of His Majesty's Principal Secretaries of State.

Which Addresses His Majesty was pleased to receive very graciously.

Venice, June 17. Several Merchant-Ships of different Nations which are come in from the Levant, have brought Advice, that the greatest Part of the Veteran Troops which were garrisoned in the Morea, were gone from thence for Hungary, so that the Garrisons were become very weak, except those of Napoli di Romania, Modon, and some others. Letters from Corfu of the 21st of last Month tell us, that the Venetian Fleet was not yet sailed from thence; that according to the freshest Advices the Turkish Fleet was at the Dardanel, but that a Squadron had been detached for Alexandria, there to take on board 5000 Turks of the Ægyptian Troops and transport them to Thessalonica, whence they are to proceed to Hungary. Four of the Pope's Gallies and two of the Duke of Tuscany's are arrived at Otranto, and wait there to be joined by the Maltese Squadron. On the 13th Instant 38 Transports sailed from hence for Corfu, with Recruits for the Grison and Italian Regiments, and with large Stores of Provisions. By a Vessel which is arrived from Dalmatia, we have an Account, that the Provveditore General Mocenigo was at Sebenico on the 2d Instant, and was to go the next Day to Spalatro, to give Orders for the March of 3000 Men which were to be embarked for some Enterprize that was kept secret.

Madrid, June 20. 'Tis advised from Balfain, that the King of Spain is pretty well recovered, not having had any Fits of Ague for several Days past; and that he intends to remove on the 25th Instant to the Escorial, for some Weeks. By Letters from Barcelona of the 12th Instant we learn, that on the 8th the Horse and Dragoons were begun to be embark-

ed, and on the 12th were most of them on board, the Infantry still lying in Quarters in the Neighbourhood, in order to imbarke last; and that it was believed the Fleet would be ready to put to Sea on the 16th or 17th. The Squadron which sailed from Cadiz the 26th of last Month to reinforce the Fleet at Barcelona, has been detained by contrary Winds on the Coast of Alicante.

Genoa, June 21. Two Maltese Ships of War which arrived here from Barcelona three Days ago, bring Advice, that about the 7th Instant the Intendant Sig. Patino received Advice by an Express from the Court of Madrid, that the Squadron from Cadiz, designed for Barcelona, had put to Sea; whereupon he immediately gave Directions for imbarking the Forces at Barcelona. We have since received Advice, by the Way of Leghorn, that on the 30th past the Cadiz Squadron was forced by Strefs of Weather to put into Cartagena. We have Letters from Cagliari in Sardinia of the 12th Instant, which say a considerable Number of Transports was arrived there, to take on board 12 Battallions and 14 Squadrons; and that 'tis not designed the Spanish Fleet shall touch at Sardinia.

Hague, July 1. In order to adjust the Points of the Barrier-Treaty which are yet in dispute, his Excellency the Earl of Cadogan, assisted with the Deputies of the Council of State on the 29th past, at the Examination of the Accompts concerning the Sums negotiated in the Netherlands, under the Administration of the Maritime Potentates; in which a considerable Progress has been made, and that whole Affair will be finished in a few Days. The Marquess de Prié having desired that Baron Heems should likewise be present at the settling the said Accompts, the States General have readily agreed to it; and he will assist in the next Conference, which is to be held on the 4th Instant. M. Dalwig, Minister here from the Landgrave of Hesse-Cassel, has received Orders from his Master to go to the Court of Great Britain, and designs to set out for England on the 5th Instant. This Morning the States of the Province of Holland were re-assembled. The Marquess Beretti Landi, the Spanish Ambassadour, had used all Methods to dissuade, and even to deter them by repeated Threats of confiscating all the Effects in Spain belonging to the Dutch, from entering into the Treaty of Alliance for the Preservation of the general Peace and Tranquility of Europe. Notwithstanding which they agreed unanimously in a Resolution to sign that Treaty: Which Resolution is to be delivered to Morrow or on Monday next to the Assembly of the States General; where the Deputies of most of the Provinces are ready to consent to this Republick's joining in the said Alliance.

Whereas a great Number of Men armed, did lately come several times in the Night, in a riotous and tumultuous Manner, into the Lord Bishop of Winchester's Park at Barnham, particularly on the 2d Instant, between the Hours of Twelve and One in the Night, and fired at the Deer, Horses and Cattle there, killing and wounding some, besides what they carried off, expressing, by their Words and Shouting, that they did it in open Defiance of the Laws, and threatening to kill the Men and Cattle in and about the Castle and Park. And whereas on Saturday the 21st Instant they came again into the said Park, and set fire to the Lodge, standing about it till it was burnt down to the Ground, after which they gave a Volley and Huzza, declaring aloud they would do further Mischief by setting Fire to the Castle, and that they would leave no living Creature about the Park. His Majesty is pleased to promise His most Gracious Pardon to any one of the Persons concerned in the said Riot, who shall discover any Two or more of his Accomplices, so as they may be apprehended and convicted.
