HM CUSTOMS AND EXCISE

SEIZURE OF EXCISE GOODS

On 2 April 2002, at 21.45 hours at Lymm, Cheshire, HM Customs and Excise detained 22,464 litres Crest Super lager at 10% alcohol by volume. Owner of the goods is said to be Solregal, c/o Andre Gide, Poligono Guadalhorce, 29004 Malaga.

Pursuant to section 139(6) of the Customs and Excise Management Act 1979, (hereinafter "the Act") and paragraph 1 of the Schedule 3 thereto, the Commissioners of Customs and Excise hereby give notice that, by virtue of the powers contained in the Customs and Excise acts the above goods are seized as liable to forfeiture by force of the following provisions namely, Regulation 16 of The Excise Goods (Holding, Movement, Warehousing and REDS) Regulations 1992, following a breach of Regulation 11(1)(a) of the same regulations.

Any person claiming that the said goods are not liable to forfeiture, must, within one month from the date of this notice of seizure, give notice of claim in writing, in accordance with paragraphs 3 and 4 of Schedule 3 to the Act. If proper notice of claim is not received within the said period of one month, or if any requirement of the above-mentioned paragraph is not complied with, the goods will be deemed to have been duly condemned as forfeited.
