THE A40 TRUNK ROAD (GOLDEN VALLEY BYPASS) (PROHIBITION OF CYCLISTS) ORDER 200

The Secretary of State for Transport hereby gives notice that he proposes to make the above-mentioned Order, under sections 1(1), 2(1) and (2) of the Road Traffic Regulation Act 1984, on the A40 Trunk Road in the boroughs of Cheltenham and Tewkesbury in the county of Gloucestershire

The effect of the Order would be to prohibit cyclists from the A40 between Arle Court Roundabout, Cheltenham and Elmbridge Court Roundabout, Gloucester.

OLD BROAD STREET—PROPOSED TRAFFIC MANAGEMENT

Notice is hereby given that the Common Council of the City of London propose to make Orders under section 6 of the Road Traffic Regulation Act 1984.

2. The effect of the Order would be to:

(a) revoke the prohibition on vehicles turning right from Old Broad Street into Wormwood Street imposed by the City of London and Hackney (Prescribed Routes) (No 1) Traffic Order 1989;

(b) revoke the compulsory straight ahead movement for vehicles from Old Broad Street (north of London Wall) into Old Broad Street (south of London Wall) imposed by the City of London (Prescribed Routes) (No 3) Traffic Order 1991;

(c) amend the City of London (Waiting and Loading Restriction) (Special Parking Area) Order 2001, so that the hours during which the existing restrictions on:

(i) waiting by vehicles apply would be changed so that they would apply at any time in the length of Old Broad Street specified in Schedule 1 to this notice:

(ii) waiting by vehicles (for the purpose of delivering or collecting goods or loading or unloading a vehicle) apply would be changed so that they would apply at any time in the lengths of Old Broad Street specified in Schedule 2 to this notice.

3. A copy of each of the proposed Orders, of the Common Council's statement of reasons for proposing to make the Orders and of a plan showing the affected street can be inspected during normal office hours on Mondays to Fridays until the expiration of a period of 21 days from the date on which this notice is published at the Department of Planning and Transportation, Guildhall, London EC2P 2EJ.

Old Broad Street:

(a) the north-west side:

(i) between the south-western kerbline of Liverpool Street and the north-eastern kerbline of Broad Street Avenue;

(ii) between the south-western kerbline of New Broad Street and the north-eastern kerbline of Great Winchester Street.

(b) the south-west side:

(i) between the southern kerbline of Liverpool Street and the northeasternmost kerbline of Bishopsgate Churchyard;

(ii) between the south-westernmost kerbline of Bishopsgate Churchyard and a point 10 metres north-east of the north-eastern kerbline of Great Winchester Street.
