# NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

Pursuant to section 139(6) of the Customs and Excise Management Act 1979 (hereinafter the Act) and paragraph 1 of the Schedule 3 thereto, the Commissioners of Customs and Excise hereby give notice that by virtue of the powers contained in the Customs and Excise Acts, certain goods, namely:

A white LDV commercial van, vehicle reg: P498 HEG, has been seized as liable to forfeiture by force of the following provisions: Hydrocarbon Oil Duties Act 1979, section 13, Customs and Excise Management Act 1979, sections 49 and 141.

If you claim that the said goods are not liable to forfeiture you must, within 1 month from the date of this notice of seizure, give notice of your claim in writing in accordance with paragraphs 3 and 4 of Schedule 3 of the Act.

If you are outside the United Kingdom and the Isle of Man, you must give the name and address of a Solicitor in the United Kingdom who is authorised to accept services of process and act on your behalf. If you do not give proper notice of claim within the said period of 1 month or if any requirement of the above-mentioned paragraph 4 is not complied with, the goods will be deemed to have been duly condemned as forfeited.

If you do give notice of claim in proper form, the Commissioners will take legal proceedings for the condemnation of the goods. Please send any notice of appeal to the following address:
