Saturday, and to introduce loading restrictions to the bus lane to operate between 7.00 am and 10.00 am and between 4.00 pm and 7.00 pm;

(b) introduce a mandatory bus lane, on the south side (westbound) of Fulham Road from a point opposite the western kerbline of Holmead Road for a distance of 190 metres in a south-westerly direction, operational between 7.00 am and 7.00 pm Monday to Saturday, and to introduce loading restrictions to the bus lane to operate between 7.00 am and 10.00 am and between 4.00 pm and 7.00 pm.

(c) introduce a mandatory bus lane, on the south side (westbound) of Fulham Road from a point opposite the western kerbline of Britanna Road for a distance of 184 metres in south-westerly direction, operational between 7.00 am and 7.00 pm Monday to Saturday, and to introduce loading restrictions to the bus lane to operate between 7.00 am and 10.00 am and between 4.00 pm and 7.00 pm.
