# Road Traffic Acts

**London Borough of Enfield** BULL LANE AND WILBURY WAY—AT ANY TIME WAITING RESTRICTIONS

#### MONTAGU ROAD AND WHARF ROAD-8.00 AM TO 6.30 PM ON MONDAYS TO SATURDAYS WAITING RESTRICTIONS

1. Notice is hereby given that the Council of the London Borough of Enfield (The Council) proposes to make the Enfield (Waiting and Loading Restriction) (Special Parking Area) (Amendment No ) Order 200 under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.

2. The general effect of the Order would be:

(a) to prohibit waiting by vehicles (otherwise than for loading or unloading purposes) at any time in certain lengths of Bull Lane and Wilbury Way (currently existing 8.00 am to 6.30 pm on Mondays to Saturdays restrictions apply on these lengths);

(b) to prohibit waiting by vehicles (otherwise than for loading or unloading purposes) between 8.00 am and 6.30 pm on Mondays to Saturdays in a certain length of Montagu Road and a further length of Wharf Road;

(c) remove a certain length of 8.00 am to 6.30 pm on Mondays to Saturdays waiting restrictions from Wharf Road.

3. Copies of the proposed Order, of the Council's statement of reasons for proposing to make the Order, plans showing the locations and effects of the proposed Order, together with other relevant documents can be inspected at the Reception Desk, "B" Block, the Civic Centre, Silver Street, Enfield, Middlesex EN1 3XD, during normal office hours on Mondays to Fridays inclusive.

4. Persons desiring to object to the proposals, or make any other representations, should send a statement in writing to that effect, and in the case of an objection stating the grounds thereof, to the Head of Traffic and Parking Services, the Civic Centre, Silver Street, Enfield, Middlesex EN1 3XD, quoting Ref LB/TG52/825, by 14 May 2003.

5. Under the Local Government (Access to Information) Act 1985, any letter you write to the Council in response to this notice may be made available to the press and to the public, who would be entitled to take copies of it if they so wished.
