- 1. Notice is hereby given that the Council of the London Borough of Enfield (The Council) propose to make the Enfield (20 mph Speed Limit) (No ) Traffic Order 200 and the Enfield (Waiting and Loading Restriction) (Special Parking Area) (Amendment No ) Order 200 under sections 6, 84(1) and (2) and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985 and the Road Traffic Act 1991.
- 2. The general effect of the Speed Limit Order would be to extend the existing 20 miles per hour vehicle speed limit zone to the road and lengths of roads specified in Schedule 1 to this notice.
- 3. The general effect of the Waiting and Loading Restriction Order would be to prohibit waiting by vehicles (otherwise than for loading purposes) at any time in certain lengths of the streets specified in Schedule 2 to this notice. (Note: certain existing waiting restrictions in those streets would be changed to apply at any time.)
- 4. Further notice is hereby given that the Council propose to construct flat top speed tables/entry treatments (not more than 100 millimetres in height) to control the speed of vehicles, under sections 90A to 90I of the Highways Act 1980 and in accordance with the provisions of the Highways (Road Humps) Regulation 1996 and the Highways (Traffic Calming) Regulations 1993, at the locations specified in Schedule 3 to this notice
- 5. Copies of the proposed Orders, of the Council's statement of reasons for proposing to make the Orders, and of plans showing the locations and effects of the proposed Orders and speed tables, together with other relevant documents can be inspected at the Reception Desk, "B" Block, the Civic Centre, Silver Street, Enfield, Middlesex EN1 3XD, during normal office hours on Mondays to Fridays inclusive.
- 6. - (i) a point 1 metre north-west of the common boundary of Nos 27 and 29 Monmouth Road and a point 4.5 metres north of the northern wall of No 47 St Martin's Road; and
- (ii) a point 8 metres east of the north-eastern kerbline of Monmouth Road, at that junction;
- (b) from a point 1.2 metres west of the common boundary of Nos 43 and 45 Monmouth Road westward for a distance of 7.7 metres (eastern kerbline of Oxford Road).

Plevna Road

- (a) from a point 30.3 metres north-east of the north-eastern wall of Nos 21 to 23 and 54 to 56 The Market Square north-eastward for a distance of 10 metres;
