Etters from Grodno of the 16th Instant give an Account, that on the 12th the Matshal of the Dyet proposed to the Deputies of the Nobility, the pailing a Refolution for confirming the last Treaty of Pacification made at Warfaw; upon which a Debate arofe, fome urging that the Au-thority of the Great Generals of the Army was too much reftrained by that Treaty, and that fome Alteration ought to be made in the Method of levying the Taxes in the Palatinates for the Payment of the Army : But most of the Deputies infisting upon the Confirmation of the Treaty intire, that Point was carried. In the Seffions held the 14th, the raifing of the Polpolite Rulzenie, that is, the Ban or Militia of the Kingdom, up on any Emergency, was refolved upon, and it was left intirely to the King's Difposition to formon the faid Militia to appear in Arms whenever he shall think fit. A Refo. lution paffed likewife, for preferving the Free-dom of voting in fucceding Dyets. And laftly, a Vote paffed for the Dyet's meeting again after a flort Adjournment, to confoit what may be proper to be done upon the Answer the Czar shall give to the Letter lately written to him to defire him to with-draw his Troops out of Poland. The 14th at Night, the King being feated on his Throne, in the Chamber of the Schators, the Deputies of the Nobility were fent for thither, and their forementioned Refolutions being presented to his Majesty, and read, the Pri-mate of the Kingdom took Exception to that for raifing the Militia, becaule it obliged the Clergy to contribute their Part to the neceffary Expence on fuch an Occafion. He was feconded by the Bishop of Warmia, both

of them infifting on the İmmunities of the Church, and the Exemption of the Clergy from the faid Charge. But the Deputies answered, that the greatest Part of the Lands of Poland and Lithuania be-long to the Church, and that as those Estates were properly Donations and Benefactions beflowed by the Republick on the Clergy, it was but reafonable they fhould contribute to the Means of Preferving the State in a Cafe of common Danger: And therefore they would not admit of any Alteration in that Refolution. The Primate made a Protestation against it; and withdrew. But the faid Refolution, and the others above-mentioned, were approved by the Senators, and received the Royal Affent's only the Time and Place of re affembling the Dyet, was referred absolutely to the King. The Palatine of Mafovia was named by his Majefty to go Ambaffadour to the Czar. And then the Dyet broke up:

Hague, Dec. 6. The Deputies of the Towns which have Sellion among the States of the Province of Holland, separated last Week to go and confult their refrective Principals, and to receive their final luftructions on the Affairs now under their Confideration; and the States of the faid Province being re-affembled to Day, the Refult of their Deliberations is expected. The Inftruments of the new Convention for the Execution of the Batrier Treaty being engroffed, have been de-livered to the Ministers of the several Parties concerned therein, that they may examine the fame in order to their meeting to fign. Baron Heems, the Emperous's Minifter, fell fick some Days ago, and is now to ill that his Life is despaired of. The two Frigates which are to fail from the Texel to cruife upon the Swedish Privateers and other Shipping, carry one of them 54 Guns, and the other 32.

At the Affizes at Wells in the County of Somerfet, the 19th of August last, he was convicted for speaking the same Words in the faid Town of Wells. At the same Assizes he was convicted for

speaking at St. George's in the faid County these Words,

He was also convicted at the same Affizes at Wells aforefaid, for preaching in thele Words in the Parish Church of Portburyz

(meaning the Pretender.) He was likewife convicted at the fame Affizes at Wells, for preaching in the Parish Church of St. George, in these Words,

) On Thursday last, the 27th of November, he was brought to the Court of King e-Bench

Westminster, to receive the Judgment of that Court for his faid Crimes.

For his abovementioned Crime in preach. ing in Portbury Church, he was fentenced to ftand in the Pillory at Charing Crofs, on Monday the 1ft of December, for an Hour, between Eleven and Two, with this Infeription over his Head, For seditious and treasonable Preaching, to be imprisoned four Years, and to find Sureties for his good Behaviour during Life, himfelf in 10001. Penalty, and two Sureties in 500 l. each.

For his abovementioned Crime in preaching in St. George's Church, he was fentenced to fland in the Pillory at the Royal Exchange on Tuesday the 2d of December, for an Hour, between Eleven and Two, with the fame Infeription over his Head, and fined 200 l.

For his other four Crimes abovementioned, he was fined 100 l. for each.

Accordingly he flood in the Pillory Yefterday at Charing-Cross, and this Day at the Royal Exchange.
