1. Notice is hereby given that the Council of the London Borough of Haringey, hereinafter called the Council, on 8 January 2004, the above-mentioned Orders under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Road Traffic Act 1991.

2. The general effect of The Haringey (Waiting and Loading Restriction) (Special Parking Area) (Amendment No 109) Order 2004 would be to further amend the Haringey (Waiting and Loading Restriction) (Special Parking Area) (No 1) Order 1994, so that waiting by vehicles would be prohibited along sections of Waltheof Gardens, London N17.

3. The general effect of the Prohibition of Stopping Outside Schools Order would be to further amend the Haringey (Prohibition of Stopping Outside Schools) (Special Parking Area) (No 1) Order 1994 so that vehicles would be prohibited from stopping:

Monday to Friday, between the hours of 8.00 am and 4.30 pm, on a section of Waltheof Gardens, London N17.
