### Road Traffic Acts

#### *London Borough of Tower Hamlets*

##### THE TOWER HAMLETS (PRESCRIBED ROUTE) (NO 3) TRAFFIC ORDER 2004

##### THE TOWER HAMLETS (PRESCRIBED ROUTE) (NO 4) TRAFFIC ORDER 2004

1. Notice is hereby given that the Council of the London Borough of Tower Hamlets proposes to make the above-mentioned Orders under section 6 of the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Road Traffic Act 1991.

2. The general effect of:

(i) The Tower Hamlets (Prescribed Route (No 3) Traffic Order 2004 will be to prohibit motor vehicles from proceeding in Gunthorpe Street between a point 7.2 metres north-west of the north-western kerblines of Whitechapel High Street and a point 19.2 metres north-west of that kerblines;

(ii) The Tower Hamlets (Prescribed Route (No 4) Traffic Order 2004 will be to prohibit motor vehicles from proceeding in Daplyn Street between a point opposite the north-eastern kerblines of Hanbury Street and a point 3 metres north-east of that kerblines.

##### THE TOWER HAMLETS (20 MPH SPEED LIMIT) (NO 2) TRAFFIC ORDER 2004

1. Notice is hereby given that the Council of the London Borough of Tower Hamlets proposes to make the above-mentioned Order under section 84(1)(a) and (2), and 124 of the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Road Traffic Act 1991.
