STOPPING-UP OF VARIOUS ROADS IN GATESHEAD

Notice is hereby given that the Borough Council of Gateshead intend to apply to the Gateshead Petty Sessional Division sitting at the Magistrates' Court, Warwick Street, Gateshead, on 17 February 2004, at 2.00 pm approximately for two Orders authorising the stopping-up of the various highways in Gateshead as described below as being unnecessary for highway purposes.

Plans showing the areas of highway to be stopped up are deposited at the office of the Strategic Director, Legal and Corporate Services, Gateshead Council, Civic Centre, Regent Street, Gateshead and may be inspected during normal office hours.

On the hearing of the applications any person who would be aggrieved by the making of these Orders shall have the right to be heard.

1. *Chopwell Hall, Chopwell Area (Ref TS/237)*

Highway 1—commences from a point on Clayton Terrace Road being approximately 30 metres north-east of its junction with Ramsay Road and Greenhead Road for a distance of 260 metres in a south-east direction to a point at its junction with the bridal path north of Wansbeck Street.

Highway 2—commences from a point on Clayton Terrace Road being approximately 110 metres north-east of its junction with Ramsay Road and Greenhead Road for a distance of 270 metres in a south-east direction a point at the unnamed road at north-east of the north-eastern boundary of the property known as 21 Wansbeck Street.

Highway 3—commences at point on Highway 2 above at a point approximately 60 metres south-east of the commencement point of Highway 2 and proceeds for a distance for approximately 50 metres in a south-east direction and then turns south-west for a distance of approximately 61 metres to rejoin Highway 2 at a point approximately 203 metres south-east of the commencement point of Highway 2.

Highway 4—commences at point on Highway 2 above at a point approximately 235 metres south-east of the commencement point of Highway 2 and proceeds to point approximately 8 metres in a south-west direction.

Highway 5—commences at point on Highway 2 above at a point 235 metres south-east of the commencement point of Highway 2 and proceeds to point approximately 11 metres in a north-east direction.

Highway 6—commences on a point on Highway 5 above at a point approximately 5 metres north-east of its commencing point of Highway 5 and proceeds to point approximately 8 metres in a northern direction.

Highway 7—commences at point on Highway 2 above at a point approximately 85 metres south-east of the commencement point of Highway 2 and proceeds for a distance of approximately 55 metres in a west-south-west direction and then in a south-south-westerly direction for approximately 12 metres.

Highway 8—commences at point on Highway 7 above at a point approximately 80 metres south-west of the commencement point of Highway 7 and proceeds for a distance of approximately 23 metres in a westerly direction to a point directly north on the north-eastern boundary of "Annfield House" Hall Road.

Highway 9—commences at point on Highway 7 above at a point approximately 88 metres south-west of the commencement point of Highway 7 above and proceeds for a distance of approximately 27 metres in a south-westerly direction to a point on eastern boundary of the property known as "Annfield House" Hall Road.

Highway 10—commences at point on Highway 7 above at a point approximately 97 metres south-west of the commencement point of Highway 7 above and proceeds for a distance of approximately 22 metres in a south-westerly direction to a point on eastern boundary of the property known as "Annfield House" Hall Road.

Highway 11—commences at point on Highway 7 at approximately 107 metres south-west of the commencement point of Highway 7 and proceeds for a distance of approximately 20 metres in a north-westerly direction to a point on eastern boundary of the property known as "Annfield House" Hall Road.

Highway 12—commences at point on Highway 7 above at a point approximately 122 metres south-west of the commencement point of Highway 7 and proceeds for a distance of approximately 21 metres in a north-westerly direction to a point at the north-eastern boundary of the property known as 4 Meadowbrook Drive.

2. *Highway Verge at Frosterley Walk Sunnyside (Ref TS/262)*

The section of highway verge to be stopped up is rectangular area being approximately 20 metres in length and 3 metres wide containing an area of approximately 60 square metres lying adjacent to the northern boundary of the property known as 36 Frosterley Walk.
