This Variation Order will make adjustments to the Scheme by:

Increasing penalty and enforcement charges for non-payment of the congestion charge as follows:

Discount Rate Penalty Charge Notice (PCN)—from £40 to £50;

Full Rate PCN—from £80 to £100; Increased Rate PCN—from £120 to £150;

Clamping Fee—from £45 to £65;

Vehicle Removal Fee—from £125 to £150; and

Vehicle Storage Fee (per day)—from £15 to £25.

This variation would not be implemented until The Mayor has reviewed the performance of the service provider.

Lowering the threshold for the congestion charging fleet schemes from 25 vehicles to 10 vehicles.

Allowing payment by additional credit and debit card types to those specified in the Scheme Order by telephone, internet, SMS text message and self-service machines.

Revising the definition of residents' vehicles to include the stipulation that the name and address for the vehicle's registration document matches the registered details. Drivers of company vehicles must provide an A4 photocopy of a company car authorisation letter and must state that the vehicle is for the sole use of the registered person. Drivers of lease vehicles must provide a copy of a vehicle lease document, which must name the registered person.

Removing the financial criteria for the NHS patients' reimbursement scheme. The two clinical criteria would remain.
