At the fame Time they gave him a Copy of the Refolution for their Acceffion. Don Louis da Cunha, formerle Ambaffadour of Portugal in Englandi and afterwards at Urrecht, fet out Yesterday for Spain, to refide there with the fame Character. We have Letters from Stockholm of the 9th and 17th of January, M Se which advile, that M. Rumpff, Refident of the States General, had had an Audience of the Queen, and was very gracioully received ; That the Prince of Heffe was arrived there ; and that the Duke of Holftein had made him the first Visit, and yielded him the Rank as Husband to the Queen; that the late Regulation of the Pofts had been abolished; that their Coin had been reduced to the antient Value; and that all the teft of Baron Goertz's Innovations in the Administration had been entirely fet afide.

Hague, Feb. 21. On the 18th the Marquels Beretti Landi had a Conference with the Deputies of the States, in which he prefented to them the Translation of a Letter from Cardinal Alb roni, tending to amule the States with the Hopes of a Mediation, and to flacken their Intentions of concurring heartily with the Allies; in Conclusion affuring them, that their Ambaffadour shall be well received in Spain.
