- (b) to enable a vehicle to wait so that any gate or barrier at the entrance to premises to or from which the vehicle is proceeding can be opened or closed if it is not reasonably practicable for the vehicle to wait elsewhere; and
- (c) when the person in control of the vehicle is:
- (i) required by law to stop,
- (ii) obliged to stop in order to avoid an accident, or
- (iii) prevented from proceeding by circumstances beyond their control.
- 4. The closures are expected to take place overnight at various times throughout the works period as follows:
