PROPOSED LUTON DUNSTABLE TRANSLINK ORDER NOTICE OF AMENDMENT TO APPLICATION DOCUMENTS

On 18 December 2003, Bedfordshire County Council, of County Hall, Cauldwell Street, Bedford, Bedfordshire MK42 9AP, and Luton Borough Council, of Town Hall, Luton LU1 2BQ, applied jointly to the Secretary of State for Transport under section 6 of the Transport and Works Act 1992 ("the 1992 Act"), for an Order under section 1 of the 1992 Act, authorising the works specified in the Schedule hereto ("the original application").

Under section 239(2)(a) of the Local Government Act 1972 ("the 1972 Act") as amended by section 20 of the 1992 Act, both Bedfordshire County Council and Luton Borough Council were required to obtain a resolution passed by a majority of the whole number of the members of each authority to authorise each authority to promote an application under section 6 of the 1992 Act, for the Luton Dunstable Translink Order. Under section 239(2)(b) of the 1972 Act, both authorities were also required to pass a resolution by a like majority at a further meeting held as soon as may be after the expiration of 14 days after the application has been deposited with the Secretary of State for Transport. Under section 239(2)(b) of the 1972 Act, if a local authority is unable to secure the second resolution it must take steps to withdraw its application.

In accordance with section 239(2)(a) of the 1972 Act, Luton Borough Council passed its first resolution on 18 September 2001. Bedfordshire County Council passed a similar resolution on 13 December 2001.

On 12 February 2004, Bedfordshire County Council failed to secure its second resolution under section 239(2)(b) of the 1972 Act. On 20 April 2004, Luton Borough Council passed the necessary second resolution required by section 239(2)(b) of the 1972 Act, to confirm the first resolution of Luton Borough Council to promote the application under section 6 of the 1992 Act, for the Luton Dunstable Translink Order. As a consequence, Luton Borough Council proposes to modify certain of the application documents and in particular the Funding Statement required to be provided by an applicant under Rule 10(3)(c) of the Application Rules. This Statement requires an applicant to set out proposals for funding the cost of implementing the Order and, in particular, funding the cost of acquiring land which is blighted land within the meaning of section 149 of the Town and Country Planning Act 1990.
