To provide a zebra crossing on York Way, southbound lane, by Camden Park Road at a point 10 metres north from the building line on opposite side of road from 105 York Way and 1 Camden Park Road, together with the zig-zag markings. As shown on Drawing No SRS4-3-1.

To provide a zebra crossing on northbound slip road from York Way into Camden Park Road at a point 7 metres from the building line of 105 York Way and 1 Camden Park Road, together with the zig-zag markings. As shown on drawing No SRS4-3-1.

To provide a zebra crossing on the slip road from the northbound lane from York Way into Camden Park Road at a point 6 metres along the kerbline north-west from the building line of 7 and 9 Camden Park Road, together with the zig-zag markings. As shown on drawing No SRS4-3-1.

The general nature and effect of the (CA-F) Order to reduce some residents parking places in Prince of Wales to accommodate a new zebra crossing. To re-designate the pay and display parking places in Greenland Place. To re-schedule the residents parking places outside No 74 Harmood Street to accommodate a new disabled persons parking place. To modify the pay and display bays in Eversholt Street. To revoke a redundant pay and display parking place in Bonny Street, which has been suspended long term.

The general nature and effect of the (CA-Q) Order to convert a redundant bus stand in Minster Road to a residents parking place. To reduce the size of the existing resident's parking bay outside No 34 Shoot-Up Hill, junction with Kingscroft Road. To re-schedule two existing parking places in Hemstal Road.

The general nature and effect of the (Market Trader/Goods Vehicles) Orders to replace the two existing parking places in Back Hill with a loading bay and relocate them to new locations in Warner Street and Eyre Street Hill.

A copy of the Orders, which will come into force on 14 June 2004, together with details/plan showing the location, may be inspected during normal office hours on Mondays to Fridays inclusive, at the Environment Department Reception, fifth floor, Town Hall, Argyle Street, London WC1H 8EQ

CYCLE LANES

- 1. To introduce a new contra-flow cycle lane in Bridge Approach (east side, between Adelaide Road and Regents Park Road).
- 2. To introduce a new with-flow or contra-flow part segregated twoway cycle lane in Regents Park Road (south-east side, between Chalk Farm Road and a point 20 metres south-west of that kerbline).
