THE BARNET (DISABLED PERSONS PARKING PLACES) (2000, NO 17) (AMENDMENT NO 17) TRAFFIC ORDER 2004

Notice is hereby given that the Council of the London Borough of Barnet have made, on 23 June 2004, an Order under section 6 to the Road Traffic Regulation Act 1984 and all other enabling powers.

The general effect of the Order will be to provide parking bays for disabled drivers as specified in Schedule 1 and Schedule 2 and revoke the parking bays specified in Schedule 3 to this notice.

A copy of the proposed Order, which will come into operation on Monday 28 June 2004, a plan of the relevant area and the Council's statement of reasons for making the Order can be inspected between 9.00 am and 5.00 pm on Mondays to Fridays (Bank Holidays excluded) for a period of 6 weeks from the date on which this notice is published at:

- (a) Traffic Section, Room 1006, Barnet House, 1255 High Road, Whetstone, London N20 0EJ; and
- (b) The Town Hall, The Burroughs, Hendon, London NW4 4BG.

Any person wishing to question the validity of the Order or any of its provisions on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any regulations made thereunder have not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.
