Take notice that A F S Dean, of Waterloo Farm, Wilsford, Grantham, Lincolnshire NG32 3NZ, is applying to the Environment Agency for a licence to abstract water from an existing catchpit into sands and gravels at National Grid Ref TF 006 445 in Wilsford, North Kesteven, Lincolnshire.

The proposal is to abstract water at the following rates: 54 cubic metres per hour, 800 cubic metres per day and 56,818 cubic metres per year, between 1 December and 31 March. Water will be stored in a sealed reservoir from which it will be used for irrigation.

The licence would effectively replace licence 4/30/11/G/116, which recently expired with an increase of 25,000 cubic metres per year and the inclusion of the month of December.

A copy of the application including a technical report, maps and plans and other documents may be inspected, free of charge, at all reasonable hours at Waterloo Farm, Wilsford, between 9 July 2004 and 9 August 2004.
