1. The Council of the Royal Borough of Kingston upon Thames, on 28 June 2004, made the following Orders under sections 6, 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended:

The Kingston upon Thames (Parking Places) (Tolworth) (No 1)
