SCHEDULE 1

Byway Open to All Traffic 77 Nelson

Description of the part of the route to be stopped up

Commencing from a point approximately 20 metres south of 24 Bamford Street (at point A on the plan) just north of a pedestrian access ramp the byway crosses Marsden Hall Road South (to point B on the plan). The byway proceeds in a generally south-easterly direction for 31 metres running roughly parallel to Marsden Hall Road South and then turns to continue in a southerly direction for a further 28 metres to the junction of the connecting track to Marsden Hall Road South roughly opposite number 4 Sycamore Avenue (point C on the plan).

SCHEDILE 2

Public Footpath 71 Nelson

Description of the part of the route to be stopped up

The part of footpath 71 Nelson to be stopped up runs from the track between Marsden Hall Road South and BOAT 77 Nelson (point D on the plan) and runs for a distance of approximately 28 metres in a southerly direction to Marsden Hall Road South (point E on the plan).
