THE A46 TRUNK ROAD (A46/A607 HOBBY HORSE ROUNDABOUT JUNCTION IMPROVEMENT) COMPULSORY PURCHASE ORDER (NO ) 200

Notice is hereby given that the Secretary of State for Transport in exercise of his powers under the above-mentioned Acts has prepared a draft Compulsory Purchase Order, entitled as above, which he proposes to make, authorising him to purchase compulsorily;

(a) the land and rights described in Schedule 1 hereto for the purpose of: (i) the improvement of the A46 Bath–Lincoln Trunk Road at Syston in the district of Charnwood in the county of Leicestershire.

(ii) the improvement of highways at Syston in the district of Charnwood in the county of Leicestershire in pursuance of the A46 Trunk Road (A46/A607 Hobby Horse Roundabout Junction Improvement) Side Roads Order 200.

(iii) use by the Secretary of State in connection with such improvements of the said Trunk Roads and other highways; and

(b) The land described in Schedule 2 hereto for the purpose of mitigating any adverse effect which the existence or use of the said Trunk Road and other highways which he proposes to improve as aforesaid will have on the surroundings thereof.

Copies of the draft Order and of the plan referred to in it have been deposited and may be seen at all reasonable hours from 24 June 2004 to 5  $\bar{A}$ ugust 2004, or within 42 days of the date of first publication of this notice if that date expires later, at the Highways Agency, 5 Broadway, Broad Street, Birmingham B15 1BL; Syston Library, Upper Church Street, Syston, Leicestershire LE7 1HR; Syston Post Office, 14 High Street, Syston, Leicestershire LE7 1GP and at Syston Town Council, Community Centre, School Street, Syston, Leicestershire LE7 1HN.

Any objection to the draft Compulsory Purchase Order must be made in writing and addressed to the Secretary of State, Highways Agency, 5 Broadway, Broad Street, Birmingham B15 1BL not later than 5 August 2004 and should state the grounds of objection and quote Ref HA 065/ 009/000189. In the preparation of an objection and the statement of grounds of objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

This requires the Secretary of State to publish his determination as to whether an environmental impact assessment should be made in respect of a particular project for constructing or improving a highway. In this case the project referred to above.

In arriving at his decision the Secretary of State must determine whether the project is one which falls within Annex I or II of the Council Directive 85/337/EEC (as amended by Directive 97/11/EC). If it is a project that falls within Annex II the Secretary of State must have regard to the selection criteria contained in Annex III of the Directive.

### **ROAD TRAFFIC REGULATION ACT 1984**

#### THE A1 TRUNK ROAD (GREAT NORTH ROAD, BEDFORDSHIRE TO CAMBRIDGESHIRE) (VARIABLE SPEED LIMIT) ORDER 200

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 84(1)(a) and (2) of the Road Traffic Regulation Act 1984 on a length of the A1 Trunk Road, between the A1(M) Junction 10, in the county of Bedfordshire and the A1(M) Junction 14 in the county of Cambridgeshire.

The effect of the Order would be to impose either a 40 miles per hour or 50 miles per hour speed limit, in conjunction with lane closures, on the A1 Trunk Road:

(a) northbound carriageway between its junctions with the entry slip road from the  $A1(M)\,Junction\,10\,Baldock\,Services$  and the exit slip road to the A1(M) Junction 14 Alconbury Interchange;

(b) southbound carriageway between its junctions with the entry slip road from the A1(M) Junction 14 Alconbury Interchange and the exit slip road to the A1(M) Junction 10 Baldock Services; and

(c) slip roads and link roads leading to or from the lengths of northbound and southbound carriageways mentioned above.

The speed limits would be enforceable only when the appropriate traffic signs are displayed and would apply to a maximum length of 4 kilometres at any one time.
