die, and law a confiderable Number of Forces ] embarked on 21 Transportas and that the curtent Reports at that Place were, That the Imbarkation confifted of 5000Eout and 600Horfe, together with 50000 fmall Arms and a great Quantity of Powder: That on the 27th of February, O.S. those Transports failed under the Convoy of two Spanish Men of War of 60 Guns each; and the Greyhound (formerly taken from the English) of 22 Guns, after six English Gentlemen in Disguise had gone on board the Commadore : And that it was faid they were defigned for Corunna, there to be joined by moreForces and then to proceed to invadeGreat Britain or Ireland. The Transports were extremely crowded, abundance of MEn being forced to lie on the Deck ; and the Cut ftraw for the Horles being packed up in Bags, they were obliged to lash those Bags a long fide the Ships, exposed to the Weather: A great many of the Men fhipped for Soldiers had been preffed in the Streets of Cadiz, and immediately hurried on board: The Horfes were ill flowed, and had been fhipped 20 Days before they left Cadiz : And no more than 21 Days Provisions were put on board with these Forces. On the 2d of March the faid Captain failed from Cadiz, and on the 7th faw a Fleet of Ships 25 Lesgues Weft North Weit off Cape St. Vincent, ftandingSouthward, the Wind at South Eaft, one of which making rowards him, he foon knew her to be the Greyhound, by which and by the Number of Ships he found it to be the Fleet which he faw fail from Cadiz: The Night coming on he got clear. By the Course they were then fleering he judges they were making back to Cadiz, having then but 11 Days Provisions left, and Corunna fo far diftant that there was no Probability of their fetching it. Soon after he parted from them he had extraordinary bad Weather, and concludes, that if they had the fame they could not reach Cadiz, but must bear away to the Canaries. It is to be observed, that he does not give the Number of Forces, Arms, Horles and Provifions above mentioned, from his own Knowledge, but from the Reports of the Spaniards. He fays that the Spaniards in Cadiz expreffed great Joy that the Catholicks in Great Britain and Ireland were now to be relieved. On the 10th of March, being in the Latitude of 40, about 70 Leagues West from Portugal, he faw eight tall Ships from 50 to 60 Guns or thereabouts flanding Southward, one of them carried a broad Pendant and Dutch Colours ; he was about a Mile to Windward of them, but as they did not attempt to chace him, he could make no Judgment what they were.

Whitehall, April 6. Letters from Captain Cavendifh, on board his Majefty's Ship Dover at Gibraltar, giving an Account of what he had learned of the failing of the Fleet from Cadiz, fay, that the Spaniards had prefied all Sorts of People; at leaft 1500, to compleat their Regiments; and were in fuch Want of Seamen, that they prefied all the Boat men they could find to Man their two largeft Ships of Wat.
