THE EALING (FREE PARKING PLACES) (NO 2) (AMENDMENT NO) ORDER 2004

THE EALING (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (AMENDMENT NO) ORDER 2004 PROPOSED LIMITED TIME FREE PARKING PLACES IN BIDEFORD AVENUE AND DOUBLE YELLOW LINE WAITING RESTRICTIONS IN BIDEFORD AVENUE AND TEIGNMOUTH GARDENS, PERIVALE

- 1. Notice is hereby given that the London Borough of Ealing Council propose to make the above-mentioned Orders under sections 6 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.
- 2. The general effect of the Orders would be:
- (a) to introduce a free parking place in Bideford Avenue, Perivale, on its north-west side, from a point 6.50 metres north-east of a point opposite the southern flank wall of No 3 Bideford Avenue, Perivale extending north-eastwards for a distance of 21 metres and to provide that the parking place will be for the use of passenger vehicles, goods carrying vehicles, motorcycles and disabled persons vehicles;
- (b) to provide that the free parking place specified in sub-paragraph 2(a) above would operate between the hours of 8.00 am and 6.30 pm on Mondays to Saturday inclusive and that parking therein would be limited to a period of 30 minutes per stay with no return by the same vehicle for a period of 1 hour thereafter;
- (c) to increase the single yellow line waiting restrictions in the same length of Bideford Road specified in sub-paragraph 2(a) above to apply between the hours of 8.00 am and 6.30 pm on Mondays to Saturdays inclusive to conform with the hours of operation of the free parking place; and
- (d) to introduce double yellow line waiting restrictions applying at any time in Bideford Avenue, on its north-west side, between the northern kerbline of Teignmouth Gardens and a point 6.50 metres north-east of a point opposite the southern flank wall of No 3 Bideford Avenue and in Teignmouth Gardens, on its north side, between the north-western kerbline of Bideford Avenue and a point 12 metres west of a point opposite the south-eastern flank wall of No 3 Bideford Avenue.
- 3. The Orders, and other documents giving more detailed particulars of the Orders are available for inspection between 9.00 am and 5.00 pm Mondays to Fridays inclusive at Mouchel Parkman, 22-24 Uxbridge Road, Ealing, London W5 2BP, until 6 weeks have elapsed from the date on which either the Orders are made or the Council decides not to make the Orders.

THE HAMMERSMITH AND FULHAM (WHITE CITY OFF-STREET CAR PARKING PLACES) ORDER 2004

- 1. Notice is hereby given that the Council of the London Borough of Hammersmith and Fulham has made an Order entitled The Hammersmith and Fulham (White City Off-Street Car Parking Places) Order 2004 under sections 32, 35 and 124 of, and Part I to Part IV of Schedule 9 of, the Road Traffic Act 1984.
- The Order will come into effect on 6 September 2004.
- 2. The general effect of the Order will be:
- (a) to introduce resident permit parking, visitor permit parking and contractor permit parking subject to the conditions specified in Schedule 1 to this notice, in parking places in White City Estate, Creighton Close and Batman Close as designated in Schedule 2 to this notice.
- (b) to introduce pay and display charges at a cost of 70 pence per half hour in parking places in White City Estate, Creighton Close and Batman Close as designated in Schedule 2 to this notice, to be used under guidelines specified in Schedule 1 to this notice

- (c) to provide that all the parking places designated in Schedule 2 to this notice be controlled from Monday to Saturday from 9.00 am to 8.30 pm (d) to provide that the parking places designated in Schedule 2 be used only by vehicles that meet the following criteria:
- (i) the vehicles must be constructed to or adapted to carry not more than 12 passengers and goods vehicles not exceeding 1,525 kilograms unladen weight;
- (ii) the vehicle must not exceed 2.28 metres in height;
- (iii) the vehicle must not exceed 5.50 metres in length.
- (e) to provide for free parking on the parking places specified in Schedule for the following categories of vehicles:
- (i) disabled badge holders;
- (ii) motorcycles
- 3. A copy of the proposed Order and the plan which shows the location and effects of the Order, and of the Council's statement of reasons for proposing to make the Order, can be inspected at the address below between 9.00 am and 5.00 pm on Mondays to Fridays inclusive, until the expiration of a period of 21 days from the date on which this notice is published.

Any person desiring to question the validity of the Order or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.
