# **Road Traffic Acts**

### London Borough of Croydon ROAD TRAFFIC REGULATION ACT 1984 THE A23 GLA ROAD (CROYDON) (RED ROUTE) TRAFFIC ORDER 2004

1. Transport for London, hereby gives notice that it intends to make the above-named Order under section 6 of the Road Traffic Regulation Act 1984.

2. The general nature and effect of the Order would be to amend and clarify the existing Red Route controls on a length of the A23 in the London Borough of Croydon, between its junction with the A232 Croydon Road and its junction with the B276 Marpit Lane. The Order includes provisions for:

(a) "double red line controls" prohibiting stopping at any time at locations where stationary vehicles will cause danger or congestion;

(b) "single red line controls" prohibiting stopping between 7.00 am and 7.00 pm on Mondays to Fridays inclusive at locations where stationary vehicles will cause danger or congestion during busy weekday time periods;

(c) "single red line controls" prohibiting stopping between 7.00 am and 7.00 pm on Mondays to Saturdays inclusive at locations where stationary vehicles will cause danger or congestion during busy day time periods; and

(d) areas marked on the carriageway which allow exemptions to the Red Route Controls, to allow for parking and loading/unloading of vehicles at certain times of the day.

3. The road that would be affected by the Order is the A23 Purley Way, Russell Hill Road, Purley Road, Foxley Lane, Banstead Road and Brighton Road in the London Borough of Croydon.

4. A copy of the Order, a statement of Transport for London's reasons for the proposals, a map indicating the location and effect of the Order and copies of any Order revoked, suspended or varied by the Order can be inspected during normal office hours at the offices of:

# THE A23 GLA ROAD (BRIGHTON ROAD, CROYDON) (BUS PRIORITY) (NO 1) TRAFFIC ORDER 2004

#### THE EALING (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (AMENDMENT NO ) ORDER 200 PROPOSED WIDTH RESTRICTION IN MIDDLETON ROAD WITH AT ANY TIME WAITING RESTRICTIONS AT ITS JUNCTION WITH DARYNGTON DRIVE
