(2) introduce a with-flow bus lane in the most offside north-eastbound traffic lane of A3036 Wandsworth Road, north of A3205 Parry Street, for the use of local buses only, at any time;

(3) introduce a with-flow bus lane in the most offside north-eastbound traffic lane of A3036 Wandsworth Road, between Miles Street and A3205 Parry Street, for the use of local buses only, at any time;

(4) introduce a with-flow bus lane in the most offside southbound traffic lane of A203 South Lambeth Road, north of A3205 Parry Street, for the use of local buses only, at any time;
