- (4) introduce a with-flow bus lane in the most offside southbound traffic lane of A203 South Lambeth Road, north of A3205 Parry Street, for the use of local buses only, at any time;
- (5) introduce a contra-flow northbound bus lane in the nearside lane of South Lambeth Place, for the use of local buses and pedal cycles only, at any time
- (6) suspend the existing south-eastbound bus lane in the nearside lanes of A202 Vauxhall Bridge and A202 Bridgefoot;
- (7) introduce bus-only routes (for the use of local buses only at any time) linking:
- (a) the bus lane referred to in paragraph 2(1) above with Vauxhall
- (b) the bus lane referred to in paragraph 2(2) above with the part of Bondway that is incorporated in the Vauxhall Cross bus station; and (c) the bus lane referred to in paragraph 2(4) above with South Lambeth Place;
- (8) introduce a bus and pedal cycle route (for the use of local buses and pedal cycles only at any time) linking Vauxhall Cross with the existing north-westbound bus lane in A202 Bridgefoot.
- 3. The roads affected by the Orders are A202 Bridgefoot, South Lambeth Place, A203 South Lambeth Road, A202 Vauxhall Bridge and A3036 Wandsworth Road.
- 4. Where it appears necessary for certain purposes, Transport for London or any person authorised by them may modify or suspend the Orders or any provisions in them, while the Orders are in force.
- 5. In due course Transport for London will be considering whether or not the provisions of the Orders should be continued in force indefinitely.
